

and Durable and Cause three fair plats and Certificates thereof to be
 made by the said Surveyor two thereof for the Contenting Parties and y^e
 third to be fairly Entered in a book for that purpose, to be provided by the
 Commissioners at the County Charge of good Large Strong Paper with
 a Leather Parchm^t Cover which said books shall be Lodged with the
 County where such Lands as aforesaid are kept among the records of the
 same County, which said bounds so ascertained and Entered as aforesaid
 shall be and remaine the certain and undoubted bounds of the said Land for
 ever, and further the said Court after having ascertained the Limits
 and bounds as aforesaid shall and may by order of this Act put either the
 Compt^r or Defendant (as the Case shall require) into Peaceable
 possession of the bounds so Determined, and also aforesaid decree all
 Costs Accruing thereupon and the Damages Suffered on such Land &
 award Execution thereon ag^t Such of the parties as they shall Judge
 to pay the same and that from all and every such Decrees and
 Determinations made by such Commissioners Elected and Chosen as aforesaid
 there shall be no Appeals or review, be the value of the Land what it
 will, but in Case any person or party Concerned or anyway Interested in the
 bounds of the Lands in Dispute shall Obstinately or willfully after
 Publication as aforesaid refuse or Delay to meet the Complainant before the
 Commissioners at the time Notified for preferring their petition or
 if present will not Joyn in Making their Election or Choice of
 such number as aforesaid out of the Commissioners Commissioned as aforesaid
 to Ascertaine the bounds of the Land in Dispute, that then in all such
 Cases it shall and may be Lawfull for the Maj^r part of the County
 not being related to either party either by Consanguinity or affinity, or any
 way Interested in the Lands in Dispute to proceed in the same Manner as
 before Mentioned to make their Decree and Determination Concerning the
 bounds of the Lands in Dispute & to aforesaid Decree all Costs & Damages
 and Execution thereon as aforesaid against the party or parties which shall
 Judge to pay the same from which Decree and Determination there shall be
 Appeals or review be allowed other then is hereafter Expressed - and be
 it further Enacted by the Authority aforesaid that every such County
 Commissioned and executing their Commission as aforesaid in Execution of
 their time and trouble in Viewing the several Land in Controversy as
 aforesaid and passing such Order and Decree as aforesaid shall for every Day they
 attend thereon be paid the Sum of one hundred pounds of Tobacco and now
 to be paid by such of the parties as the County shall Judge to pay the
 same and for ascertaining what part the Surveyor shall Receive -
