

this Case shall be made, the said Surveyor shall have such fees as by Law are setled  
 for primitive Surveys, but if in Case it should be found needfull to Survey and run out  
 only one or more Lines of any of the adjacent Lands that then the Surveyor for every  
 such Line or Lines by him run shall have only a Quarter of a pound of Tobacco p  
 perch and no more and if it shall so happen that his Lordships Surveyor of the County  
 shall be either a person Interested in any of the said Disputes or related to either  
 party or that any Just Deception be made against him and allowed by the said  
 Comm<sup>rs</sup> then the said Commissioners shall appoint some other skilfull and  
 honest person in his stead to performe that Service, AND for the better dispatch  
 of business by the said Commissioners, Be it Enacted by the authority a<sup>fo</sup> that  
 that the said Commissioners shall and may by their wisdoms and Diverctions  
 order and settle such Justices and rewards for such Clerk and other officers and  
 assistants as they shall Judge necessary to be by them appointed and employed,  
 all which said officers and assistants so appointed as a<sup>fo</sup> shall give their  
 due Attendance at the time and place appointed and do and performe such  
 Services in furtherance of this Act as shall be then and there directed them  
 by the said Commissioners under such penalties as by the said Commissioners shall  
 be adjudged not exceeding One hundred pounds of Tobacco, to be Levied by way of  
 Execution to the use of the said Commissioners on the body goods and Chattles  
 of each of such offenders and for the more Effectuall putting this Act in  
 Execution, Be it further Enacted by the authority a<sup>fo</sup> by and with the  
 Advice and Consent a<sup>fo</sup> that all Sheriffs Coroners and Constables within this  
 province and other the officers a<sup>fo</sup> shall pay a due obedience to any precept  
 whatsoever that shall be directed to any of them from the Comm<sup>rs</sup> a<sup>fo</sup> or to any  
 other precept whatsoever and shall be under like pains or penalties for  
 disobeying or contemning thereof and shall in all things be aiding and  
 assisting to such Commissioners in their severall Offices as they are or ought  
 to be to their severall and respective County Courts or to any single Justice  
 thereof, for all which Services by such Sheriffs or Coroners to be performed by  
 virtue of this Act they shall be allowed <sup>half the fees that are allowed</sup> them by Law in other cases for such like  
 Services and shall not charge or exact more on pain of incurring the penalties  
 directed by the Act for Limitation of Officers fees a<sup>fo</sup> the offenders thereof, and  
 to protect the said Commissioners from being molested and Disturbed in the  
 Execution of their Commissions Be it further Enacted by the  
 authority a<sup>fo</sup> that if any person or persons whatsoever shall presume to  
 molest Disturb or obstruct the said Commissioners Surveyor or any other  
 officer or assistant in performance of their duty a<sup>fo</sup> in any Case within  
 the directions of this Act shall forfeit and pay to the Lord proprietaries Cust  
 and Treasurers for the support of government the sum of one thousand pou  
 nds to be recovered in any Court of record within the Province within  
 the space of six months after the said forfeiture shall be made.
