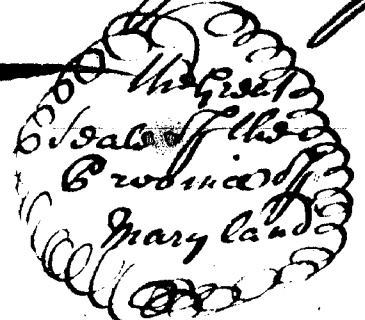

An Act for the Relief of J<sup>es</sup> M<sup>r</sup> Claster of Southolt  
County Gentleman

Whereas the said J<sup>es</sup> M<sup>r</sup> Claster in the year seventeen hundred and nine  
became bound w<sup>th</sup> John Bowman late Sheriff of Somerset County in the sum  
of two hundred thousand pounds of T<sup>or</sup> for the Due Execution of the Office  
of said Bowman <sup>which</sup> some years since very considerably <sup>was</sup> <sup>increased</sup> <sup>to</sup> <sup>be</sup> <sup>from</sup>  
for T<sup>or</sup> received by him as Sheriff that the Creditors of the said Bowman  
have caused the said M<sup>r</sup> Claster to be sued on the said bond of whose Judgment  
is recovered for the penalty thereof, And whereas the said Bowman had but  
a very small private Estate and that what he did possess of hath been  
already applied to the payment of his Debts so that nothing remains  
whereby the said M<sup>r</sup> Claster may be indemnified and that by the Laws of this  
Province the bond entered into by the said Bowman is not assignable to the said  
M<sup>r</sup> Claster nor the heir at Law of the said Bowman liable thereon. At this  
the said M<sup>r</sup> Claster request It is therefore Enacted by the Rt Honble  
the Lord Proprietary by and with the advice and Consent of his Lordships Governour  
the upper and lower houses of assembly and the Authority of the same; that  
it shall and may be Lawfull for the Governour of this Province at the Justice  
and request of the said J<sup>es</sup> M<sup>r</sup> Claster to assigne the said John Bowmans bond to him  
the said J<sup>es</sup> M<sup>r</sup> Claster and that the said J<sup>es</sup> shall be and is Enabled by this  
Act to have an action or actions to be commenced thereon and the same to  
proceede w<sup>th</sup> any force in the same manner that hath been used by  
publick Creditors his the said M<sup>r</sup> Claster being bound in the said bond
