 Summons and Transferring their Estates as aforesaid shall take his or their Sollemn Oath or
 Oaths or Test before the said two Justices of the severall and respective Countys aforesaid so to be
 Summoned as aforesaid to the Effect following viz

"I A B D. Sollemnly Swear that the
 "Good, Dobts and Effects which I have Delivered Assigned and Made Over to the
 "Sheriff of County And in Trust for the use of my Creditors is the whole Estate
 "both real and personal of my Own in Possession or have any Title to in the World
 "And that I have not any Estate goods or Effects of any kind whatsoever left either
 "in possession reversion or remainder the necessary wearing Apparel for my self
 "Wife and Children Excepted And that I have not Directly or Indirectly sold leased
 "or otherwise conveyed Disposed of or trusted All or any part of my Estate thereby
 "to secure the same to receive or expect any Profit or Advantage thereof &c
 "help me God. - It shall and may be lawfull for the Sheriffs of the severall and

respective Counties of, Charles, Anne Arundell Calvert Queen Annes and Dorchester aforesaid after
 the end of the said Twenty Days And the said Sheriffs are hereby required to Discharge the said
 Thomas Turner Christopher Bohoss Thomas Cobb John Gould Thomas Bozly John Farrel
 John Coments John Kauloy John Boldom and Joseph Gough Out of Custody And to Suffer
 them to go at large. And be it further Enacted by the Authority aforesaid and Council aforesaid
 that upon the said Thomas Turner Christopher Bohoss Thomas Cobb John Gould Thomas Bozly
 John Farrel John Coments John Kauloy John Boldom and Joseph Gough their Complying with
 what is required of them by this Act that they the said Thomas Turner Christopher
 Bohoss Thomas Cobb John Gould Thomas Bozly John Farrel John Coments and Joseph
 Gough And every of them their and every of their heirs Executors and Administrators shall
 be by Virtue of this Act acquitted Exonerated released and Discharged of and from all manner
 of Debts Duties Claims and Demands whatsoever that have been severally contracted by
 them or have arose Due or become Demandable from them at any time before the sitting
 of this present General Assembly And that in case the said Thomas Turner Christopher
 Bohoss Thomas Cobb John Gould Thomas Bozly John Farrel John Coments John Kauloy
 John Boldom and Joseph Gough, or either of them shall after such their Complyance and Dis-
 charge as aforesaid be arrested or sued for any such their Debts or Duties as aforesaid or
 that the said Sheriffs shall be sued for any matter or thing required of them or either of
 them to be Done by this Act that then the said Thomas Turner Christopher Bohoss Thomas
 Cobb John Gould Thomas Bozly John Farrel John Coments John Kauloy John Boldom
 and Joseph Gough or the said Sheriffs or either of them whom it may concern may take
 a Common Apperance or Apperances without Special Bail to any such Action or Actions
 as shall be brought against them any or either of them, And plead thereto the Generall
 Issue
