

Any or either of them or within this province within Twenty Days after the
 end of this session of a ssembly go to the sheriff of the several Counties in which
 the Prisoners before mentioned are respectively Detained or kept in Custody
 and give good Security to say the Imprisonment fees at Four Shillings of Silver
 for Day that shall or may be owing due from the said Prisoners or any or either
 of them after the end of the said Twenty Days and also to find the said Prisoners
 or any or either of them Sufficient Meat Drink and Coaling during their future
 Imprisonment in Case they or any of them the Prisoners aforesaid shall be
 and Surrender or Cause to be Delivered up and Surrendered to the sheriff of the
 County in whose Custody they are in the Prisoners of two Justices of the Peace
 in each of the said Counties whom the said sheriffs are hereby required to Summon
 on the request of the said Prisoners or any of them at the Dwelling Plantations or
 Places of Abode of the said Prisoners or any of them at some convenient
 time between the first Day of November next and the fourth Day of December
 next All their Real and Personal Estates either in Possession Reversion Remain-
 der or in trust or in or unto which they have or any or either of them
 hath any Claim or Interest whatsoever and Do likewise between the Days aforesaid
 mentioned convey Assign Transfer and Make Over unto the sheriff of such
 County wherein the said Prisoners or any of them are Detained in Goal
 for the use of their said Creditors All such their Estates Interest or Claim as
 aforesaid after such Manner as by the said sheriff and the Major Part of the
 said Creditors or of such of them as shall think fit to Direct therein or
 their Council bearing in the Law shall reasonably Devise or require At
 the Cost and Charges of such Prisoners as shall Claim the Benefit thereof so
 as the said Prisoners nor any of them be not burthensd with any Pen-
 -alties thereby Other then from themselves and those that Claim by from
 or Under them and that the said Prisoners and every one of them at the
 time of such their Surrender and transferring their Estates as aforesaid
 shall take his or their Solemn Oath before the said two Justices of the Se-
 -veral and Respective Counties as so to be Summoned as aforesaid to the Effect
 following viz

I A B Do Solemnly Swear that the Goods Debts
 and Effects which I have Delivered Assigned Made Over to the sheriff
 of County and in trust for the use of my Creditors is the
 whole Estate both real and Personal of my own in Possession or have
 any Title to in the world (save as to John Medcalf) such Lands as I now
 hold, or have any Title to in Right of my wife and that I have not
 any Estate Goods or Effects of any kind whatsoever left either in
 Possession Reversion or Remainder (the Newspaper bearing Apparell
 for my self wife and Children excepted) and that I have not directly or
 Indirectly sold Leased or otherwise Conveyed Disposed of or Intended
 All
