Buy or either of them or willm this Province within Twenty Days after the
End of this Session of Assembly go to the Sheriff of the several Countye in which
the Prisoners before mentioned are respectively Detained or kept in Custody
And give good Securitey to Pay the Imprisonment fees at the County of Robart
for Day that shall or may come & up from the said Prisoners or Buy or either
of them after the End of the said Twenty Days And Also to find the said Prisoners
or any or either of them Sufficient Meale Drink and Cloathing during their fute
Imprisonment in case they or any of them the Prisoners aforesaid shall Detain up
and demand or cause to be Detained up and demanded to the Sheriff of the
County in whose Custody they are in the Person of two Justices of the Peace
in each of the said Counties whom the said Sheriff are hereby required to summon
on the request of the said Prisoners or any of them at the Dwelling plantations or
Places of Abode of the said Prisoners or any of them at some convenient
time between the first Day of November next And the tenth Day of December
next All their Real and Personal Estate either in Possession Recovery Remai
ner or in trust or in or Mise which they have or buy or either of them
have Any Claim or Interest whatsoever And Do likewise within the Days afte
-mentioned Convey Assign Transfer and Make Over unto the Sheriff of such
County to detain the said Prisoners or any of them are Detained in Gaol
for the loss of their said Creditors All such their Estates Interest or Claim as
aforesaid after such manner as by the said Sheriff and the Major Part of the
said Creditors or of such of them as shall think fit to Direct therew or
their Councillors met in the same shall reasonably Direct or require At
the Cost and Charges of such Persons as shall claim the Benefit thereof so
as the said Prisoners nor any of them be not burdened with Any hea
vynys thereby other then from themselves And those that claim by from
or under them And that the said Prisoners and every one of them at the
time of such their Surety and transferring their Estates as aforesaid
shall take his or her Solemn Oath before the said two Justices of the se
veral and respective Counties of so to be summoned as aff to the effect
following viz

I A B Do Solemnly Swear that the Goods Dels
and Effects to whch I have Delivered Assigned & Made Over to the Sheriff
of County And in trust for the loss of my Creditors is the
whole Estate both real and Personal of my own in Possession or have
Any Title to in the world (Save as to John Medcalf of Sheen Lands as I have
had, or have Any Title to in Right of my wife And that I have not
Any Estates Goods or Effects of any kind whatsoever left either in
Possession Recovery or Remainder (the Houldary weareing Apparell
for my self wife and Children excepted) And that I have not directly or
Indirectly sold leased or otherwise Conveyed Disposed of or given away
