who dare try them by this Commission. In fine, the whole Course of his Life is so Turbulent and Disorderly, that he hath very rarely been clear of some Criminal Profecution or other in the Provincial Court for many Years, Some of which he hath been Convict of, altho' his Artful and audacious Management of the Subtil and Tricking part of the Law, hath acquitted him from many more, which with as much Justice he deserved Punishment for. That in many more instances, too tedious to insert, the said Macnamara has behaved himself with Insolence and Contempt; all which the Several Justices, after some Resentments, have past over, in hope of his Reformation, but such is his intolerable Pride and Insolence, that of late he has not Scrupled to Insult and Affront his Excellency, both as Governour and Keeper of the Great Seal, as may evidently appear by two Indictments now depending in that Court, found against him by the Grand Inquest for this Province, and the Reasons for his Suspension in the Chancery Court, of which their Lordships have been impartial Judges. That since their Lordship's Determination and Commands has no Effects upon his Proud and Turbulent Spirit, We who have the Honour of his Lordship's Commission, delpair of putting the Laws in due Execution for punishment of vice or Maintenance of Vertue and Justice, without being the mark of his Scorn and Revenge, which rather than be liable to, We again declare it to be our firm Resolution, That we will no longer continue in that station, if so Turbulent and Insolent a Person be allowed to practice before us.

## A Supplementary Act to the Act for appoint ment of Constables, and what relates to their Office, and ascertaining what persons are Taxables.

DE it Enacted by the Right honourable she Lord Proprietor, by and with the Advice and Consent of his Lordsbip's Governour, and Upper and Lower Houses of Assembly, and the Authority of the same, That in case any Constable shall not pursue the directions of the A& of Assembly now in force relating to his Office, and of this Act, in the taking and returning of Taxables, such Constable shall be fined to the Right Honourable the Lord Proprietor, in the Sum of five hundred Pounds of Tobacco for each Offence, One half thereof to the Informer, or him or them that shall Sue for the same, and the other half thereof for the use of Free-Schools in luch County where the Forseiture shall happen to be recovered in such County Court, by action of Debt, Bill, Plaint or Information, wherein no Essoyn, Protection or Wager of Law to be allowed.

And be it further Enacted, That in ease any Master, Mistress, Dame, or other chief Person of the Family, shall conceal any Taxable; or not give a true account thereof to such Constable, pursuant to the directions of the Act asoresaid, that then such person shall for every Taxable so concealed, or not given in as aforesaid, forseit the Sum of five hundred pounds of Tobacco in manner asoresaid to the uses aforesaid to be recovered, as asoresaid.
