Day of Otlober, Seventeen Hundred and Twenty Eight, may be paid and discharged in Grain, as aforesaid, in Manner aforesaid.

AND WHEREAS, the Laws heretofore made to prevent falle Packing Tobacco, and false Taring Tobacco-Hogsheads, have not had the designed Effect; Therefore, for the more effectual preventing such dishonest and fraudulent Practices for the suture,

BE IN ACTED, by the Authority aforesaid, That any Perfon who shall false pack any Hogshead of Tobacco, as false Packing is described in and by an Act, Intitled, An Act, securing Merchants and Others Tobacco, after they have received it; and the declaring the Altering the Mark or Quality thereof to be Felony; and against saile Packing; and shall-pay, on tender the same in Payment; and shall be convict of such salse Packing, shall forseit Four Hundred Pounds of Tobacco, for every Hogshead so salse packed, to the Person to whom such Tobacco shall be paid or tendered.

PROVIDED, That such Person shall prosecute for the said Penalty, within Four Days after his Discovery of such salse Packing: And, in Default of such Prosecution, that the Offender shall forseit and pay the Quantity of Four Hundred Pounds of Tobacco for every salse-packed. Hogshead, to any other Person who shall prosecute for the same.

AND BE IT FURTHER ENACTED, That any Person, to whom any such salse-packed Hogshead of Tobacco shall be paid, or tendered, and who shall connive at, or conceal such salse Packing, or negatest or sorbear to prosecute for the said Penalty within Four Days next after the Discovery of such salse Packing, and be thereof convict, shall forfeit and pay for every salse-packed Hogshead so connived at, or concealed, to the Informer, or the Person who shall sue or prosecute for the same, the Quantity of Four Hundred Pounds of Tobacco.

tender in Payment, any Hogshead of Tobacco, whereon the Weight of the Hogshead shall not be cut or marked, according to the Direction of the Act ascertaining the Gauge and Tare of Tobacco-Hogsheads; and to prevent cropping, cutting, and defacing Tobacco taken on board Ships, or Vessels, upon Freight; and for laying Impositions on Tobacco per the Hogshead, for the Support of Government; and for the encouraging Lordship's Alienation Fines and Quit Rents, for the Term therein protosed; the l'ublick Charge; shall sorseit Four Hundred Pounds of Tobacco, to the Person to whom any untared or false tared Hogshead shall be paid, or tendered to be paid.

PROVIDED, Such Person shall prosecute for such Penalty within Four Days after the Payment or Tendering any untared Hogshead; and within Four Days after the Discovery of any falle tared Hogshead: And in Default of Prosecution, by such Person, to whom any untared or false tared Hogshead shall be paid, or tendered, within Four Days, as aforesaid, that then any other Person may prosecute for, and recover the said Penalty of Four Hundred Pounds of Tobacco, for every Hogshead, so as aforesaid salse tared or untared.
