ACT to Enable the Visitors of the Free School of <i>Kent</i> County for the Time being, to Lease one Moiety of the Land, except Ten Acres, belonging to the same School.	1

An ACT Impowering the Justices of <i>Prince George's</i> County, to Levy on the Taxable Inhabitants of <i>Queen-Anne</i> Parish in the said County, the Sum of <i>One Hundred Pounds</i> Current Money of <i>Maryland</i> , for the Uses therein mentioned.	6
An ACT for the Relief of <i>Nicholas Hammond</i> , <i>Peter Topping</i> , <i>Edward Cooley</i> , <i>Henry Templeman</i> , <i>William Bajoot</i> , <i>Anne Rind</i> Widow, and <i>Mary Penn</i> languishing Prisoners in <i>Anne-Arundel</i> County Goal, <i>Joseph Macclister</i> , a languishing Prisoner in <i>Somerset</i> County Goal, and <i>Patrick Mac Vay</i> , a languishing Prisoner in <i>Cecil</i> County Goal.	7
An ACT for the Relief of <i>Charles Sewall</i> of <i>St. Mary's</i> County, <i>Esq;</i> and other Purposes therein mentioned.	11
An ACT for the Assessment and Payment of the Publick Charge of this Province.	13

And the following Private Laws :

- An ACT to cut off the Entail of a Parcel of Land called *Roper's Neck*, and to enable *Benjamin Howard* to convey the same in Fee in Exchange for other Lands.
- An ACT for the cutting off the Entail and investing an Estate of Inheritance in Fee Simple in part of a Tract of Land called *Coopers Purchase* in *Thomas Spalding* and *Catharine* his Wife, and to Entail other Lands lying in *St. Mary's* County in lieu thereof.
- An ACT investing *Archibald Douglas* of *Cecil* County Son and Heir of *William* and *Mary Douglas*, Deceased, with an Estate in Fee Simple in the one Moiety of a Tract of Land called the *Level* or *Scutt's Level*, lying in *Baltimore* County.
- ACT to cut off and bar the Entail of part of a certain Tract of Land called *Williams's Range* in *Prince George's* County, and to convey the same in Fee Simple in the said Lands in lieu thereof.
