faid Land re-

fuling or neglecting to

Landing, on Potomack River in Prince-George's County aforesaid, shall not within the space of Eighteen Months after the End of this Session of Assembly, Build one good substantial Brick, Stone, or Framed House, of Seventy Feet long, and Twenty-two Feet wide, in the Clear, and Nine Feet Pitch, well Weather-boarded, if Framed, and tightly covered with Shingles, and under-pinned with Stone and good Mortar, to as to render the same dry, and sufficient to keep safe Tobacco, or other Goods which from Time to Time or at any Times then after the Building aforefaid is compleated, shall be brought to the Landing aforesaid, and required to be there kept or stored, That then and in such case it shall and may be lawful to and for any Person or Persons whatsoever, to apply to the Magistrates of the said County, in Court sitting, and defire that an Entry may be made in his, her, or their Names, of any one Acre of Land situate and lying on the Land aforefaid, for the Building thereon a Rolling-House according to the directions of this Act, and the said Justices are hereby impowered and directed to cause the Clerk of the County Court asoresaid, to enter the Name of such Person or Persons so requiring the same, and his, her, or their Request as aforelaid; and the faid Clerk is hereby Ordered and Directed to make such Entry accordingly.

Surveyor, &c. to lay out the faid Acre of

And be it further Enacted by the Authority aforesaid, That the said Justices shall immediately upon such entry being made, order the said Clerk to make out a Warrant to the Sheriff of Prince-George's County aforesaid, to call to his Assistance the Surveyor of the same County, as also to summon Twelve good and sufficient Freeholders of his County, to meet at Rock-Creek Landing on Potomack River, within a Space in such Warrant to be mentioned, not exceeding Thirty Days after the Date thereof, and cause the said Surveyor to lay out one Acre of Land most suitable and convenient on the Land aforesaid, for Building thereon a Publick Rolling-House, and the said Acre of Land to lay out in a Square, and the same cause to be Marked or Bounded at each Corner with good large Locust Posts let into the Ground at least Two Feet, and Three Feet out; and a Certificate of such Survey to return into the Office of the Clerk of Prince-George's County in Thirty Days after making the same; and the said Clerk for the Time being is hereby obliged to enter the same among the Records of his County.

And be it likewise Enacted by the Authority aforesaid, That the said Sheriff shall and he is hereby obliged to Swear the said Jury, that they be sworn by the Sheriff. shall and will to the best of their Skill and Knowlege value the said one Acre of Land in Current Money of Maryland, for Building thereon a Ware-house, or Rolling-House, sor the Public Service of the Neighbourhood, or such as shall make use thereof; and the said Jury so Summoned and Sworn, are hereby obliged and impowered to value the same in Current Money, and such Valuation to certify under their Hands and Seals, thentioning therein of what Tract of Land or Lands the faid Acre is Part; which Certificate the said Sheriff is hereby directed and impowered to annex to his Warrant and the Certificate aforesaid, and the same return into the Office of the County Clerk, certifying on the Back of fuch Warrant the
