Money or Bills of Credit by them received or lodged in the faid Office, for the Use of the Public of the Province aforesaid; and that the same be applied to any Uses for which it had been heretofore appropriated by any Law of this Province heretosore made, and at the Time of such Repayment in Force.

And for a further Encouragement for the Persons aforesaid voluntarily inlisting as aforesaid, Be it Enasted by the Authority aforesaid, That all and every such Person as aforesaid, who shall inlist, and serve his Majesty in the Expedition aforesaid, having first received the Bounty aforesaid by this Act granted, and after the same Expedition is over shall return to this Province, within eighteen Months after his being discharged from his Majesty's Service atoresaid, having a Certificate of such Discharge, and of his good Behaviour during the Service, under the Hand and Seal of his Captain, or other superior Officer, shall by Virtue of this Act, from the Time of his Return aforesaid, for the Space and Term of seven Years from thence next following, be exempted from the Payment of any Public, County, or Parish Taxes or Levies whatsoever; and also shall be free and clear from all or any Service or Attendance in making or clearing the Highways of this Province; any Law, Usage, or Custom, to the contrary not with standing.

And be it further Enacted, That all and every such Person aforesaid, To pass free nlisting and receiving the Bounty aforesaid, shall pass and repass over all Ferries within this Province Ferriage-free, whilst such Person or Persons hall continue in his Majesty's Service, and be in the actual Exercise of

And for the better ascertaining the Time of Return of the Persons or And to pro-coldiers aforesaid from the Expedition aforesaid, Be it further Enacted, duce Certifi-That he or they so returning, shall apply to the Court of the County here he or they shall incline to reside, to be held next after such Reurn, and produce to the Justices of that Court his or their Certificate or Certificates of Discharge asoresaid; which Certificate or Certificates the me Justices respectively are hereby required to cause to be inrolled ahongst the Records of their Courts, and an Indorsement to be made by heir Clerk, under his Hand and the Seal of such Court, of the Day of he Inrollment thereof; from which Day the Exemptions aforesaid for he seven Years aforesaid shall commence. And that it may the more cerinly appear what Persons have so voluntarily inlisted themselves in his dajesty's Service as aforesaid, and who may hereaster claim the Exempon and Encouragement above granted, the said several and respective gents are hereby required and obliged to return Lists of such Persons so listed in their respective Counties (and in what Company, and under hat Captain and Lieutenant), to one or more Justice or Justices of their pective Counties; which Justice or Justices shall produce the same to the respective Clerks in the Records of their respective Counties, ex Ficio, without Fee or Reward.
