Provided always, That nothing herein contained shall be construed to Provided hinder any Inspector from receiving his Pents in Tobacco, which shall be first viewed, examined, and stamped, according to the Directions of this Act.

And be it likewise Enasted, That where Plaintiff or Desendant, in any Suit now commenced, or that shall hereaster be commenced in any Court within this Province, in whose Favour any Judgment shall be given, so as to intitle such Plaintiff or Defendant to his or her Cost, and who shall pay the said Cost, or any Part thereof, in the Current Money of this Province, in all such Cases it shall and may be lawful for the Party against whom fuch Judgment shall be rendered, and he or she is hereby enabled to discharge all, or so much of the said Cost in Current Money, at the Rate of twelve Shillings and fix Pence per Centum, as shall be really and bon a fide paid by the Party in whose Favour such Judgment for Cost shall be given; any Law to the contrary in any wife notwithstanding.

And be it likewise Enasted, That all Tobacco made before the first All Tobacco Day of December, Seventeen hundred and forty-seven, and which shall not be carried to some Warehouse at or before the last Day of OHober next, shall be, and is hereby declared to be under the same Restrictions, and liable in all Respects to the like Inspection, and under the same Penalties and Advantages, to all Intents, Constructions and Purposes whatever, as all Tobacco now is or shall be, which has been or shall be made since the aforesaid first Day of December, Seventeen hundred and forty-seven; any

Law heretofore made to the contrary in any wife notwithstanding.

And be it likewise Enacted, That so much of an Act of Assembly entituled, An Act for amending the Staple of Tobacco, for preventing Frauds in bis Majestv's Customs, and for the Limitation of Officers Fees, so far as relates to the shipping off, and taking on board any Ship or Vessel for Transportation, any old Tobacco, made at any Time before the first Day of December, Seventeen hundred and forty-seven, be, and is hereby declared to be abrogated, repealed, and made null and void: And also so much of an Act of Assembly entituled, An Act for Relief of Debtors, and ascertaining the Manuer of Tenders in Tobacco, and the Supplementary Act thereto, lo sar as relates to Tenders made in Tobacco, be and are hereby declared, from and after the last Day of Offober, Seventeen hundred and fitty, to be abrogated, repealed, and made null and void, for and during the Continuance of the laid Act entituled, An Ast for amending the Staple of Tobacco, for preventing Frauds in bis Majesty's Customs, and for the Limitation of Officers Fees.

And be it likewise Enacted, That it shall not be lawful for any Skip- Every Stipper of any Flat, Sloop, or other Vessel, aster the End of this Session of Be. to take Assembly, to take any inspected Tobacco branded, or other Tobacco fit an Oath. for shipping off, from any Warchouse within this Province, in order to carry the same on board any Ship or other Vessel for Exportation, before such Skipper shall make Oath before the Inspector or Inspectors of such House or Houses (who are hereby authorized and required to administer the same) "That all such inspected, or other Tobacco, which he shall frome time to " time take on board such Flat, Sloop, or other Vessel, he the said Skipper will, with all Opportunity of Wind and Weather, convey, or cause

" to be conveyed, on board such Ship or Vessel, to which it shall be diet rected by the Owner or Owners thereof, to be loaden for Exportation;

and that he the said Skipper will not take, nor suffer to be taken by a-" ny Person whatever, any Tobacco out of such Hogshead or Hogsheads,

" whilst the same shall remain under his Care and Management." And if any Skipper as aforefaid shall refuse or delay taking the Oath afore-[May, 1750.] H
