A Supplementary and Explanatory Act to an Act entituled, An Act for the more effectual Punishment of Negroes and other Slaves, and for taking away the Benefit of Clergy from certain Offenders; and a Supplementary Act to an Act entituled, An Act to prevent the tumultuous Meetings, and other Irregularities, of Negroes and other Slaves.

THEREAS by an Act of Assembly of this Province entituled, Preamble. An Act for the more effectual Punishment of Negroes and other Slaves, and for taking away the Benefit of Clergy from certain Offenders; and a Supplementary Act to an Act entituled, An Act to prevent the tumultuous Meetings, and other Irregularities, of Negroes and other Slaves, and directing the Manner of trying Slaves, made at a Session of Assembly, begun and held, at the City of Annapolis, on the Fisteenth Day of May, in the Year of our Lord, One Thousand Seven Hundred and Fifty One, amongst other Things, it was enacted, " That if any Slave shall " happen to be flain for refusing to surrender him or herself, contrary to Law, Recital of " or in unlawful resisting any Ossicer, or other Person, who shall apprehend, or Part of a for-" endeavour to apprehend, such Slave or Slaves, and such Officer or other Per- mer Act. " fon fo killing fuch Slave as aforesaid, making Resistance, shall be, and he is " by this Act, indemnified from any Profecution for such killing aforesaid." And whereas some Doubts may possibly arise about the Construction of the said recited Clause, and whether the Person so killing such Slave as aforesaid, making Resistance, shall undergo any Prosecution for the same; for the Explanation whereof, and to prevent all Disputes or Doubts which may arise

concerning the faid Clause, II. BE it Enacted, by the Right Honourable the Lord Proprietary, by If any Slave and with the Advice and Consent of his Lordship's Governor, and the refisting any Upper and Lower Houses of Assembly, and the Authority of the same, Officer, the Party killing, That nothing in the above recited Act contained shall be construed to into undergo a to undergo a demnify any Officer, or other Person, killing any Slave or Slaves resisting, or Trial. refusing to surrender, from undergoing a legal Trial; any Thing contained in the said Act to the contrary notwithstanding: But that it shall and may be lawful for any Person upon his or her Trial, for killing any Slave or Slaves, to give this, and the above recited Act, in Evidence, upon Not guilty pleaded, and if it shall appear, upon the Evidence, that such killing as aforesaid, was done in the lawful Execution and in Pursuance of the aforesaid Act, that then such Person or Persons, so killing as aforesaid, in Pursuance and in the lawful Execution of the aforesaid Act, shall be acquitted and discharged thereof, and from all Penalties, Forseitures and Punishments, for such killing as aforefaid.

III. AND be it Enasted, That where any Person or Persons shall be The Expence profecuted for killing a Slave or Slaves resisting, as by the said Act entituled, to be borne profecuted for killing a Slave or Slaves resisting, as by the said Act entituled, by the Public.
