

IX. AND whereas it appears to this present General Assembly, That the said *Jonas Green* hath done divers Services as Printer for this Province, for which he hath not heretofore had any Allowance: *Be it therefore Enacted*, That the Commissioners of the Loan-Office for the Time being, shall and do pay to the said *Jonas Green*, or his Order, the Sum of Five Hundred Pounds Current Money, in full Satisfaction for such his Services; which said Sum of Five Hundred Pounds Current Money, the said Commissioners are hereby directed and required to take out of the Sum of Nineteen Hundred and Ninety-nine Pounds Twelve Shillings, paid into the said Office by Virtue of the Act, entituled, *An Act for his Majesty's Service*, passed at a Session of Assembly begun and held at *Annapolis* the Seventeenth Day of *July*, Seventeen Hundred and Fifty-four, to replace the like Sum of Money taken out of the Treasurer's Hands.

An Allowance for past Services.

X. AND be it further Enacted, by the Authority aforesaid, That the said *Jonas Green* shall Print, Stitch, and Cover with Marble Paper, blue Paper, Vellum or Parchment, the Bill, entituled, *An Act for granting a Supply of Forty-five Thousand Pounds for his Majesty's Service, and for defraying the Expences heretofore incurred for the Defence and Security of the Frontier Inhabitants of this Province, and for other Purposes therein mentioned, and for raising the same by an equal Assessment upon all Estates Real and Personal, and Lucrative Offices and Employments*, together with the several Messages relative thereto, and the same deliver by the last Day of *October* next, in like Manner as the Votes and Proceedings of the Lower House of Assembly are by this Act directed to be delivered, one Copy thereof to the Governor, one other Copy thereof to each Member of the Upper and Lower Houses of Assembly, one other Copy thereof to the Clerk of each House of Assembly, and Three Copies thereof to every Clerk of the several and respective County Courts of this Province, for the Perusal of the Inhabitants of the several and respective Counties.

XI. THIS Act to continue till the Second Day of *April*, which shall be in the Year of our Lord One Thousand Seven Hundred and Sixty-five, and no longer.

Continuance.

*An Act empowering the Justices of Baltimore County Court, to assess and levy a Sum of Current Money, and for other Purposes therein mentioned.*

I. UPON Application made by Petition to this General Assembly, from sundry Inhabitants of *Saint Paul's Parish* in *Baltimore County*, *Be it Enacted, by the Right Honourable the Lord Proprietary, by and with the Advice and Consent of his Lordship's Governor, and the Upper and Lower Houses of Assembly, and the Authority of the same*, That it shall and may be lawful to and for the Justices of *Baltimore County Court*, for the Time being, and they are hereby directed and required to assess and levy on the Taxable Inhabitants of the aforesaid Parish, in the County aforesaid, the Sum of Six Hundred Pounds Current Money, together with the Sheriff's Salary of Five Pounds per Cent for Collection, at Three equal annual Assessments, in the same Manner and under the same Terms as the County Charges are usually assessed and levied; and that the Reverend *Mr. Thomas Chase, Major Thomas Franklin, Mr. William Baxter, Mr. John Ridgely, Mr. Nicholas Ruxton Gay, Mr. Mayberry Helms, and Mr. John Enfor, junior*, or the major Part of them, are hereby authorized, directed and required, to buy and purchase in Fee, in the Name of the Rector, Vestry-men and Church wardens of the said Parish, Two Acres of Land in the Parish aforesaid, at a Place called and known by the Name of *T L*, for a Chapel of Ease to the said Parish; and the aforesaid *Thomas Chase, Thomas Franklin, William Baxter, John Ridgely, Nicholas Ruxton Gay, Mayberry Helms, and John Enfor, junior*, or the major Part of them, are hereby authorized, directed, and required, to agree and contract with a Workman or Workmen, to undertake, erect, build, and in a Workman-like Manner to compleat and finish on the aforesaid Two Acres of Land, a Chapel of Ease to the aforesaid Parish, and the aforesaid Two Acres of Land, when bought, and the aforesaid Chapel of Ease, when built, and they are hereby Enacted and Declared to be vested in the said Parish, as the Estate and Chapel of Ease to the aforesaid Parish, for the Worship and Service of God, in like Manner as other Lands, and Chapels of Ease thereon built, in other Parishes, are used and enjoyed.

600 l. to be levied in *St. Paul's Parish* in *Baltimore*, at 3 equal Assessments, for Building a Chapel of Ease.

II. AND be it further Enacted, by the Authority, Advice and Consent aforesaid, That the aforesaid *Thomas Chase, Thomas Franklin, William Baxter, John Ridgely, Nicholas Ruxton Gay, Mayberry Helms, and John Enfor, junior*, or the major Part of them, be, and they are hereby authorized and impowered, from Time to Time, as Occasion shall require for the Purpose aforesaid, to draw upon the Sheriff of *Baltimore County*, in whose Hands the aforesaid Sum of Six Hundred Pounds Current Money, so as aforesaid to be assessed and levied, or such Part thereof as shall, by Virtue of this Act, be so assessed and levied, shall remain, for so much of the said Money as they the said *Thomas Chase, Thomas Franklin, William Baxter, John Ridgely, Nicholas Ruxton Gay, Mayberry Helms, and John Enfor, junior*, or the major Part of them, shall, from Time to Time, think it necessary to draw, towards Satisfaction or Payment for the Purchase of the aforesaid Two Acres of Land, and for building, finishing and compleating the Chapel of Ease aforesaid. And the said Sheriff is hereby authorized and obliged, from Time to Time, to pay the same to such Orders accordingly, so far as the said Sum, thereout first deducting his Commission for Collection, shall extend unto.

Sheriff to pay, on the Order of the Gentlemen appointed.

III. AND be it further Enacted, by the Authority aforesaid, That the said Chapel of Ease, when built, shall be deemed and used as a Chapel of Ease for the said Parish, to all Intents and Purposes, and Divine Service shall be therein performed by the present Incumbent of the said Parish, and his Successors, every Third Sunday, and the said Chapel of Ease shall be kept constantly in Repair at the Charge of the Parish of *Saint Paul's* aforesaid for Ever.

The Incumbent to officiate every Third Sunday.
