Ditto. A Supplementary ACT to an Act, entitled, " An Act for erect-

" ing a County School in Worcester County, and appointing

"Vifitors for the fame."

Preamble.

HEREAS by virtue of the said Act for erecting a County School in Worcester County, and appointing the Visitors for the same, and of another Act, entitled, An Act for the Encouragement of Learning, and erecting Schools in the several Counties within this Province, the Visitors of the same County School are authorized and directed to purchase One Hundred Acres of Land, or more, for the Use of the said School. And whereas it is represented to this General Assembly, that the Funds of the said School are insufficient for purchasing so large a Quantity of Land, that it will be more commodious and convenient to purchase, in lieu thereof, Four Lots of Ground in the Town of Snow-Hill, for the Use of the said School:

Visitors of Worcefter to Hill;

II. Be it therefore Enacted, by the Right Honourable the Lord Proprietary, purchase Four by and with the Advice and Consent of his Lordship's Governor, and the Upper Lots in Snow. and Lower Houses of Assembly, and the Authority of the same, That the Visitors of the said School, for the Time being, or the major Part of them, be, and are hereby authorised, impowered, and directed, with all convenient Speed, to purchase Four Lots of Ground in the Town of Snow-Hill, in the said County, to them and their Successors for ever, for the Use of the said School; and cause to be erected and built, a public School for the County aforesaid, on such Part of the said Four Lots of Ground, as for that Purpose shall be assigned by the said Visitors, or the major Part of them.

And to receive a Moiety from the Visitors of Somerset;

III. And whereas at the Time of the erecting the said County of Worcester by the Division of Somerset County, there was a very considerable Sum of Money in the Hands of the Visitors of Somerset County School, which still remains in their Hands, the one Moiety whereof, ought in Equity and Conscience, to be applied to the Use of Worcester County School, Be it theresore Enasted by the Authority aforesaid, That the Visitors of Somerset County School, for the Time being, shall be, and are hereby made accountable to the Visitors of Worcester County School, and are hereby ordered and enabled to pay to them, one Moiety of the Money which was in the Hands of the said Visitors of Somerset County School, at the Time of the Division aforesaid, of the said County of Somerset, and the said Visitors of Worcester County School, for the Time being, are hereby impowered to demand and receive from the said Visitors of Somerfet County School, for the Time being, the said Moiety for the Use of Worcester County School, and in case of Resusal, to sue and implead the said Visitors of Somerset County School, for the Time being, to account for the same Moiety, and to pay the same to them, for the Use of Warcester County School aforesaid.

But not to be paid out of their private Monies.

IV. Provided always, and be it Enacted, That the Visitors of Somerset County School, for the Time being, shall not be answerable to satisfy the Money appearing due by the Account to be rendered, or Recovery to be had, as aforesaid, out of their own private Monies, or Estate, but that the same be paid and satisfied, or if necessary, levied out of the Monies belonging to the said Samerset County School, now in the Hands of the Visitors thereof, or the Treasurers, or which shall hereaster come to their, or any of their Hands.
