. III. Provided always, and be it hereby Enaded, That it shall and may be CHAP. lawful for the Taxable Inhabitants of this Province, upon whom the above May be paid. Sums of Tobacco shall be affested, to discharge and pay the same in Gold and in Money. Silver, at the same Rates as by the Act entitled, An Act for amending the Staple of Tobacco, for preventing Frauds in his Majesty's Customs, and for the Limitation of Officers Fees, made at a Session of Assembly begun and held at the City of Annapolis, the Fourth Day of October, in the Year of our Lord One Thoufand Seven Hundred and Sixty-three, Gold and Silver is directed to be received in all Payments made in virtue of that Act.

IV. Provided always, That the said Jonas Green shall actually reside at proviso, in Annapolis, during the Continuance of this Act, and comply with the Terms case of his thereof; and that upon the Death of the said Jonas Green, or his Removal. from Annapolis, or ceasing to comply with the Terms of this Act on his Part, the Payment of the Sums of Money herein before directed to be paid to him, shall cease, any Thing contained in this Act to the contrary notwithstanding.

V. And be it likewise Enacted, That the Copy of the Public Laws, made The Laws to at this present Session of Assembly, as well as those made at any future Session, have Margiduring the Continuance of this Act, shall have Marginal Notes made and mal Notes, printed thereto, as also the Date of the Year, wherein such Laws were respectively made, inserted in each Page, and a List of such Laws made at the End of each Session, with the Page wherein they are Printed; all which the said Jonas Green is hereby required and obliged to do, as well as all other Services herein before mentioned, for the yearly Salary aforesaid.

VI. And whereas the Law for the Encouragement of the said Jonas Green, His Allowdid expire the Second Day of April, Seventeen Hundred and Sixty-five, where- ance for the by the said Jonas Green can have now no Allowance by Assessment, in Man-present Year; ner aforesaid directed from this Province, for the Year Seventeen Hundred and Sixty-five aforesaid; Be it therefore Enatted, That the Treasurer of the Western Shore, for the Time being, shall, and do pay unto the said Jonas Green, or his Order, the Sum of Two Hundred and Sixty Pounds Gold Currency, out of the Public Money now in his Hands, in full Satisfaction of his Salary in the Year Seventeen Hundred and Sixty-five aforesaid.

VII. Provided that the said Jonas Green, before he be entitled to receive On produthe said Money, shall produce to the said Treasurer a Certificate from the cing the Sheriff's Re-Sheriff of Anne-Arundel County, for the Time being, that he shall have re-ceipt. ceived from the said Jonas Green, the public printed Laws, and the Votes and Proceedings of the last and present Session of Assembly, by the Tenth Day of May next.

VIII. Provided also, That it shall and may be lawful for the Sheriffs of Proviso, in the several and respective Counties respectively, and they are hereby required case of his Failure of not to pay to the said Jonas Green the said respective Sums of Money herein Duty. before mentioned, or any Part thereof, to be assessed and levied for his Use, for his Salary for this present or any future Year, during the Continuance of this Acr, unless it shall be made appear to them by a Certificate or Receipt from the Sheriff of Anne-Arundel County, for the Time being, that the Public Laws, and the Votes and Proceedings of this Session, and every future Seffion or Convention, during the Continuance of this Act, were printed and delivered to him within the respective Times herein before directed; any Thing herein before contained to the contrary, in any wife, notwithstanding.
