

III. And whereas, it is thought as safe, and more easy to the People, that several Warehouses, which by the said recited Act, are under the Care of Two Inspectors, should hereafter have but One Inspector at each House: **Be it Enacted**, That at the next Return of Inspectors by the Vestries, and always afterwards, during the Continuance of the above recited Act, the Vestry of *Chester* Parish, in *Kent* County, shall return but Two Inspectors for the Warehouse on *Worton* Creek, in the said County, One of which only shall serve at the said Warehouse, and shall be paid the Salary of Four Thousand Eight Hundred Pounds of Tobacco, and the Vestry of *St. Luke's* Parish, in *Queen-Anne's* County, shall return but Two Inspectors for *Wells's* Warehouse, in the said County, One of which only shall serve for the said Warehouse; and shall be obliged to attend on the Mondays and Tuesdays in each Week only, except particularly required, and be paid the Salary of Four Thousand Eight Hundred Pounds of Tobacco: And that the several Vestries, who by the said recited Act, are to return Inspectors for the Warehouses at *King's-Town*, *Parson's* Landing, *Emerson's* Landing, *Bruff's* Landing, at *Sherwood's* Landing upon *Broad-Creek*, and at *Oxford*, in *Talbot* County, shall return but Two Inspectors for each of the said Warehouses, One of which only shall serve at the said Warehouses, and be paid the Salaries hereafter mentioned: To the Inspector at *King's-Town* Warehouse, Six Thousand Four Hundred Pounds of Tobacco: To the Inspector at *Parson's* Landing, Six Thousand Four Hundred Pounds of Tobacco: To the Inspector at *Emerson's* Landing Warehouse, Nine Thousand Six Hundred Pounds of Tobacco: To the Inspector at *Bruff's* Landing Warehouse, Seven Thousand Two Hundred Pounds of Tobacco: To the Inspector at *Sherwood's* Landing Warehouse on *Broad-Creek*, Six Thousand Four Hundred Pounds of Tobacco: And, To the Inspector at *Oxford* Warehouse, Eight Thousand Pounds of Tobacco.

IV. And be it Enacted, That in Case of the Sickness, or other Inability of any one of the said Inspectors to attend his Duty, it shall and may be lawful for him, and he is hereby required to nominate and appoint one other Person, being a Planter, and well skilled in Tobacco, to act in his Room, during the Time the said Inspector shall be unable to attend; the said Person, so appointed, first taking the Oath of Office, and other Oaths, or Affirmation, if a Quaker, as are directed by the above-recited Act to be taken by Inspectors, and subscribing the Oath of Abjuration, and repeating and subscribing the Test. And the said Inspector, and his Sureties, shall be answerable for the Tobacco Inspected and Passed by the Person so by him appointed, in the same Manner as if he had personally officiated.

V. And whereas, it has been represented to this General Assembly, That the Salaries allowed by the above-recited Act, to the Inspectors at *Pomunkey* and *Chickamuxon* Warehouses, in *Charles* County, and at the Warehouses at *Wiccomico*, and on *Gilbert Mackey's* Plantation in *St. Mary's* County, and at the *Elk-Ridge* Landing, and *Indian* Landing, in *Anne-Arundel* County, are too small, and inadequate to their Care and Trouble, in their Office of Inspectors: **Be it Enacted**, by the Authority, Advice, and Consent aforesaid, That for this present Year, and for every future Year, during the Continuance of the above recited Act, there shall be allowed and paid, to each of the Inspectors at the Warehouses aforesaid, the Sum of Eight Hundred Pounds of Tobacco, over and above the Salaries allowed to them by the Act aforesaid; which said Sum of Eight Hundred Pounds of Tobacco, to each of the Inspectors at *Pamunkey* and *Chickamuxon*, and at *Wiccomico*, and on *Gilbert Mackey's* Plantation, and at *Elk-Ridge* Landing, and *Indian* Landing Warehouses aforesaid, shall be allowed and paid in the same Manner as Inspectors Salaries are allowed and paid by the said Act.
