An ACT for the Relief of certain languishing Prisoners in the several Jails therein mentioned.

And be it Enacted, by the Right Honourable the Lord Proprietary, by and be discharged with the Advice and Consent of his Lordship's Governor, and the Upper and Lower Houses of Assembly, and the Authority of the Same, That in case the said Prifects on Oath. soners shall deliver up, and surrender, or cause to be delivered up, and surrendered, to the Sheriffs of the respective Counties aforesaid, in the Presence of Two Justices of the Peace, of the Counties aforesaid, whom the said Sheriffs ate hereby required to summon, at the Request of the said Prisoners, at some convenient Time, after the End of this Session of Assembly, all their Real and Personal Estate, either in Possession, Reversion, Remain-
