II. Be it therefore enacted, by the Right Honourable the Lord Proprietary, C H A P. by and with the Advice and Consent of his Governor and the Upper and Lower XXI, XXII. Houses of Assembly, and the Authority of the same, That the Commissioners The Land of of Baltimore-Town, or the major Part of them, do, and they are hereby John Moale directed and required, at any Time before the last Day of April next, to and Andrew Cause the aforested Parcel of I and to be forward and I and to be cause the aforesaid Parcel of Land to be surveyed and laid out into Lots, laid out in Streets, and Lanes, at the proper Costs and Expences of the said John Streets, &c. Moale and Andrew Stigar, according to their respective Number of Part of Bal-Acres, in such Manner as to the said Commissioners, or the major Part timore-Town, of them, shall seem convenient; and that when the same shall be done, the said Parcel of Land shall be, and is hereby declared to be, Part of Baltimore-Town aforesaid, to all Intents and Purposes, as fully and amply as if originally included therein, and have the same Immunities and Privileges as the said Town, by any Law or Laws heretofore made, ought to have.

A P. XXII.

An ACT for the speedy and effectual Publication of the Laws of this Province, and for the Encouragement of Anne Catharine Green, of the City of Annapolis, Printer.

E it enasted, by the Right Honourable the Lord Proprietary, by and Allowance in with the Advice and Confent of his Governor, and the Upper and A. C. Green, Lower Houses of Assembly, and the Authority of the same, That there shall be allowed to Anne Catharine Green, of the City of Annapolis, Printer, the several and respective Quantities of Tobacco, in the several Counties within this Province, following, to wit:

In Baltimore County, Six Thousand Three Hundred and Forty. Anne-Arundel County, Four Thousand Two Hundred and Fifty. Charles County, Three Thousand Six Hundred and Four. Prince-George's County, Three Thousand Eight Hundred and Forty. Frederick County, Six Thousand Two Hundred and Thirty-three. Queen-Anne's County, Three Thousand Four Hundred. Saint Mary's County, Two Thousand Eight Hundred and Sixty-eight. Dorchester County, Three Thousand Three Hundred and Seventy. Kent. County, Two Thousand Five Hundred and Sixty-seven. Talbot County, Two Thousand Four Hundred and Thirty-four. Somer fet County, Two Thousand Six Hundred and Two. Worcester County, Two Thousand Six Hundred and Seventy. Cæcil County, Two Thousand One Hundred and Twenty-one. Calvert County, Seventeen Hundred and One.

Which said respective Sums of Tobacco, the Justices of the several County Courts within this Province are hereby impowered and required to allow and affets, in their respective County Levies, annually, during the Continuance of this Act, together with the Sheriff's Salary of Five per Cent. for collecting the same: And the several Quantities of Tobacco, to to be allowed and affested as aforesaid, shall be collected by the Sheriff of each respective County, and yearly paid by them respectively, free from any Abatement or Deduction, to the said Anne Catharine Green, or her Order, for printing, stitching, covering with marble or blue Paper, Her Duty for and delivering a Copy of the public Laws, made in this present Session such Allowof Assembly, by the Tenth Day of May, in the Year One Thousand Seven Hundred and Seventy-four, and the Votes and Proceedings of the Lower House of Assembly of this present Session, by the Tenth Day of June,

in the several Counties.
