offending, shall forfeit and pay the Sum of Ten Pounds, to be recovered C H A P. XXIV, XXV. and applied as before directed.

VIII. And be it further enacted, That nothing herein contained shall Persons may extend, or be construed to extend, to prevent any Person or Persons kill Deer within their whatsoever from killing Deer within their actual Inclosures, or Islands, Inclosures, or in that Part of Frederick County lying to the Westward of the North Ec. Mountain.

IX. This Act to continue for and during the Term of Twelve Years, Continuance. and until the End of the next Session of Assembly which shall happen after the said Twelve Years.

## C H A P. XXV.

An ACT for the Repair of the Paper Currency Office.

HEREAS it is represented to this General Assembly, That Preamble. the said Office is in want of immediate Repair,

II. Te it enacted, by the Right Honourable the Lord Proprietary, by Commissionand with the Advice and Consent of his Governor, and the Upper and Lower ers for emit-Houses of Assembly, and the Authority of the same, That the Commissioners Credit to afor emitting Bills of Credit shall, and they are hereby impowered and re gree with quired, as foon as conveniently may be, to agree with proper Workmen workmen to to repair the said Office, in such Manner and Form as to them shall seem per Currency proper, and shall and may pay the Expence thereof out of the Interest Office, &c. arising from the Loan of Bills of Credit emitted by Virtue of the Act, entitled, In Act for emitting Bills of Credit, and other Purposes therein mentioned.

## C H A P. XXVI.

An ACT for emitting Bills of Credit, and applying Part thereof.

HEREAS an Emission of Bills of Credit is, at this Time of Preamble. general Scarcity of Specie, thought expedient for carrying on the Trade and Commerce of this Province, and for answering divers other beneficial public Purposes;

II. Be it therefore enasted, by the Right Honourable the Lord Propri-Bills of Creetary, by and with the Advice and Confent of his Governor, and the Upper dit to be and Lower Houses of Assembly, and the Authority of the same, That Bills of der Direction Credit, of the Denomination of Dollars and Parts of a Dollar, to the A- of the Commount of Four Hundred and Eighty Thousand Dollars, that is to say, Two Hundred and Sixty-fix Thousand Six Hundred and Sixty-fix Dollars, and Two Third Parts of a Dollar for Loan, Eighty Thousand Dollars for the Purposes herein after particularly mentioned, and for such other Purposes as shall hereaster be appointed by Act of the General Asfembly, and One Hundred and Thirty-three Thousand Three Hundred and Thirty-three Dollars and One Third Part of a Dollar, for the Purpose of exchanging such of the said Bills as shall be emitted in virtue of this Act, and which shall become torn, defaced, and unfit to pass, shall be printed and struck with all convenient Speed, on good fingle Paper, under the Care and Direction of the Commissioners appointed, or to be appointed, by virtue of an Act, entitled, An Act for emitting Eills of Credit, S E
