Action of Debt, founded on this Act, or Indictment, wherein no Essoin, C. H. A. P. Protection, or Wager of Law, or more than one Imparlance shall be allowed, any Thing in this Act herein before contained to the contrary thereof in any wife notwithstanding, one Moiety to the Informer, the other Moiety to the Use of the Alms and Work-House of said County; in which Action of Debt it shall be sufficient for the Plaintiff to allege, that the Defendant or Defendants are indebted to the Plaintiff the Sums of Money or Tobacco by this Act directed and inflicted, whereby the Plaintiff's Action accrued to him, according to the Form of this Act of Assembly, without setting forth the special Matter: Provided a short Note expressing the Cause of Action be lodged in the Office at the Time of issuing the Writ.

XXII. And be it surther enasted, That all Sheriffs, Bailiffs, Consta-Sheriffs, &c. bles, and all other Officers and Ministers of Justice, shall be aiding and to aid & assist assilling to the said Trustees for the Poor in the said County, and to all we. fuch Officers as shall be employed by them, as by this Act is directed, in the Execution and Performance of the said Service.

XXIII. And be it sutther enacted, That if any Person or Persons shall Persons proat any Time or Times be fued or profecuted for any Matter or Thing by fecuted in him or them done and executed in pursuance and execution of this Act, this Act may or of any Matter or Thing in this Act contained, such Person or Persons plead the shall and may plead the general Issue, and give this Act and the special general Issue, Matter in Evidence for his or their Defence; and if upon Trial a Verdict fliall pass for the Desendant or Desendants, or if the Plaintiff or Plaintist's shall become nonsuited, or discontinue his or their Suit, then such Defendant or Defendants shall have and recover treble Costs to him or them awarded against such Plaintiff or Plaintiffs, and if the Plaintiff or Plaintiffs is of are unable to latisfy the lame, then it shall be paid and satisfied by the Attorney who brought such Suit, unless the Plaintiff of Plaintiff's shall give Security for the Costs, to be approved of by the Court in which such Suit is brought.

XXIV. And, To prevent Individuals being unreasonably burthened Trusees to with the Execution of this Act as Trustees for the Poor, Be it enacted, choose a new That at the Time of the Masting of the City Tand That at the Time of the Meeting of the said Trustees for the Poor in instead of the of them. in the County aforesaid, shall and may elect and choose one of of them, in the County aforesaid, shall and may elect and choose one of the best Inhabitants of the same County to be a Trustee for the Poor of that County, in the Stead of the first named or eldest of the said Trustees of the same County, which said first named or eldest Trustee shall be, and is by virtue hereof, thencefrom discharged from his Office.
