be done for their respective counties, and by order of the justices for the time being, the following sums, viz. For Saint Mary's, Kent, Anne-Arundel, Charles, Somerset, Dorchester, Baltimore, Cæcil, Prince-George's, Talbot, Queen-Anne's, Worcester, Frederick and Washington counties, tweive pounds each: For Calvert, Harford, Caroline, and Montgomery counties, ten pounds each. And all the respective county clerks within this state, for the time being, shall, and they are hereby obliged to do all the said services, and such others, for the use of the respective counties, as shall be required by the justices of the peace for each respective county, from time to time, and at all times hereafter, for and in confideration of the said allowance; and if any person, chargeable with officers sees as aforesaid, shall neglect or refuse to pay the same within the time asoresaid,

XXVII. Be it enaued, That it shall and may be lawful for the sheriff may distrain goods, riffs immediately after the last day of August yearly, to distrain the &c. goods and chattels of the person or persons to neglecting or refusing, and to fell and dispose thereof at the expiration of five days after distress made, at public auction, all which shall be done by the said sheriff without fee or reward; and the overplus beyond what will fatisty the demand aforesaid shall be returned to the debtor.

XXVIII. And he it enacted, That if any person indebted for such Persons refulfees shall resule to pay money within the time aforesaid, or shall neglect &c. may be or refuse to shew to the sheriff any goods or chattels to be distrained, executed, &c. in such case it shall and may be lawful for the sheriff to take such person in execution for the money so due as aforesaid; and the sheriff shall and he is hereby directed and required, before the last day of June yearly, to pay to each creditor, according to their respective debts or claims, all the tobacco he shall have received in satisfaction thereof, before the tenth day of June, and shall also, before the last day of September yearly, pay to each creditor; and if any sheriff shall not make payment according to the directions of this act, such sheriff shall forfeit and pay to the party grieved, if he sues the sheriff, only double the tobacco or money to be recovered with costs by action of debt, or action on the case, sounded on this act, in which it shall be sufficient for the plaintiff to allege, that the defendant is indebted to the plaintiff, or received to the plaintiff's use, the sum of money or tobacco claimed by him, whereby the plaintiff's action accrued to him according to the form of this act, without fetting forth the special matter; but if the party sucs on the sheriff's bond, he shall recover only his debt, interest and cost.

XXIX. And he it enacted, That no profecution or suit shall be com- suits to be commenced menced for any penalty or forfeiture imposed by this act, unless within within one one year from the time of the offence committed.
