XVIII, and he it enacted, That every person, chargeable with the Persons treble tax as aforesaid, shall be disabled from commencing or prosecut- with treble ing any suit in any court of this state, for the recovery of any debt or tax disabled from comdamages, for any money or tobacco due or owing to him in his own mencing suit, right, or from exercising and practising the trade of merchandise, unless, previous to such suit or merchandising, he shall take the oath or affirmation as aforesaid; and, in case of neglect thereof, the court before whom such suit shall be brought shall, ex officio, enter judgment of nonfuit; and if any fuch person shall exercise and practise the trade of merchandise, without previously taking the oath or affirmation as aforesaid, he shall, for every such offence, forfeit and pay five pounds for every hundred pounds of property such person shall be deemed worth on the public affessiment of all property within this state.

XIX: And be it enasted, That every person, chargeable with the And practitreble tax aforesaid, shall be for ever disabled and rendered incapable to the law, practife the law, physic, or surgery, or the art of an apothecary, or to preach or teach the gospel, or to teach in public or private schools, or to hold or exercise, within this state, any office of profit or trust, civil or military, or to vote at any election of electors of senators or of delegates to the liouse of delegates; and if any such person shall offend against this act, in any of the particulars above specified, he shall, for every luch offence, forfeit and pay five pounds for every hundred pounds of property he shall be deemed worth on the public assessment of all property within this state.

XX. Provided nevertheless, and be it enacted, That if any per- Provide. son, required by this act to take the oath or affirmation aforesaid, and whose name or mark shall not be found subscribed as aforesaid, shall make it appear to the governor and council, within fix weeks after the first day of March next, or to the county court of the county where such person resides, which shall sirst happen after the said first day of March next, that such person is not a person offending against this act, and, if of the age of eighteen years, at the time of such application to the governor and council, or county court, as aforesaid, shall take the said oath, or affirmation (as the case may be), such person shall not be subject to the said treble tax and disabilities aforesaid; and, on acquittal by the faid governor and council, or by the faid county court, fuch person, shall obtain a certificate thereof, and be entitled to have his name enrolled in one of the magistrates books as aforesaid; and if such person has been set down on the list chargeable with the treble tax and transmitted to the commissioners, the said commissioners are hereby enjoined, on such person's producing the certificate aforesaid, to correct the said list, and give notice thereof to the collector.
