XXV. And be it enacted, That the money shall be paid immediately on the service done, and the registers in chancery and court of admiralty respectively shall, every half year, pay the same to the treasurer of the western shore, for the use of the public, and shall annually lay before the general assembly a fair account of their receipts, and shall be allowed a commission of ten per cent. in full for their trouble and service in the execution of this act. C H A P XVIII.

An ACT to encrease the allowance of magistrates, and for other purposes therein mentioned.

WHEREAS the business of the justices of the peace out of court, by the duties enjoined them in several late acts of assembly, is greatly encreased, and the high price of all the necessaries of life being such as renders the per diem allowance inadequate to their expences, and it being thought reasonable to allow justices Preamble.
