states, and have landed property within this state; and raise produce thereon, to draw such supplies from their said farms and plantations as they may want for the subsistence of themselves and samilies, such persons previously to such permission making oath, that such supplies are wanted for such purposes, and not for sale.

CHAP.

XII. Provided also, That in case the governor and council shall at Proviso. any time think a suspension of this act necessary or proper, the governor, with the advice of the council, is hereby authorised and empowered, by his proclamation, to permit and suffer the exportation generally out of this state of all or any of the said commodities; any thing to the contrary notwithstanding.

XIII. And be it enacted, That if any action or suit shall be com- Besendant menced against any person or persons, for any thing done in pursuance general issue; of this act, the defendant or defendants, in any such action or suit, &c. may plead the general issue, and give this act and the special matter in evidence, at any trial to be had thereupon, and that the same was done in pursuance and by the authority of this act; and if it shall appear so to have been done, the jury shall find for the defendant or defendants, and if the plaintiff shall be nonsuit, or discontinue his action after the desendant or defendants shall have appeared, or if judgment shall be given upon any verdict or demurrer against the plaintiff, the defendant or defendants shall and may recover treble cost, and have the like remedy for the same as any defendant or defendants hath or have in other cases by law.
