continue the embargo above mentioned in the state of Maryland until the end of the next session of the general assembly, and may issue their proclamation accordingly; but in case the states of Pennsylvania and Delaware, or either of them, should take off the embargo on their ports for provisions of the species above mentioned, so that the trade be open in the bay of Delaware, then and in such case the governor and council are hereby authorized and requested to issue their proclamation to take off the embargo by the above bill imposed in this state, and shall and they are hereby required to issue their proclamation accordingly; and the governor and council are requested to transmit a copy of this act to the executive powers in those states, that they may have notice thereof, and desire them to make known any act or acts of their respective states on that subject.
