VIII. Be it enacted, That every act and thing done in virtue of their appointment aforesaid, as inspectors, be and is hereby rendered valid, and of the same effect, as if they had actually received their warrants.

C H A P. XII.

An ACT to continue the acts of assembly therein mentioned.

E it enacted, by the General Assembly of Maryland, That an act of affembly, entitled, An act for the relief of such persons as cannot find surety for their appearance to testify as a witness against any person arrested, accused or prosecuted, for any criminal matter, made at a session of assembly begun and held at the city of Annapolis on the third day of June, anno domini seventeen hundred and fiftytwo, be and is hereby continued, and shall remain and be in full force, for and during the term of seven years, and to the end of the next session of assembly which shall happen after the end of the said seven That one other act of assembly, entitled, An act to enable the several and respective county clerks within this province to remove some of the county records and papers from the public offices, made at a session of assembly begun and held at the city of Annapolis the tenth day of May seventeen hundred and forty-eight, be and is hereby continued, and shall be and remain in full force, for and during the term of seven years, and to the end of the next session of assembly which shall happen after the end of the said seven years.
