That one other act of assembly, entitled, An act for the better regulating attachments, made at a session of assembly begun and held at the city of Annapolis on the fifteenth day of June, seventeen hundred and seventy-three, be and is hereby continued, and shall be and remain in full force, for and during the term of seven years, and to the end of the next session of assembly which shall happen after the end of the said seven years. That one other act of assembly, entitled, An act concerning estates tail, and the jurisdiction of the county courts, made at a session of assembly begun and held at the city of Annapolis on the fifteenth day of June, seventeen hundred and seventy-three, be and is hereby continued, and shall be and remain in full force, for and during the term of one year, and to the end of the next session of assembly which shall happen after the end of the said one year. That one other act of assembly, entitled, An act for the speedy recovery of small debts out of court, made at a session of assembly begun and held at the city of Annapolis on the sixteenth day of June, seventeen hundred and seventy-seven, be and is hereby continued, and shall be and remain in full force, for and during the term of one year, and to the end of the next session of assembly which shall happen after the end of the said one year. That one other act of assembly, entitled, An act for the enlarging the powers of the governor and council, made at a session of assembly begun and held at the city of Annapolis on the eighth day of November, seventeen hundred and seventy-nine, and a supplement to the act, entitled, An act for enlarging the powers of the governor and council, made the same session, be and are hereby continued, and shall be and remain in full force, until the end of the next session of assembly. That one other act of assembly, entitled, An act to compel the attendance of the members of the general assembly, made at a session of assembly begun and held at the city of Annapolis on the twenty-third day of March, seventeen hundred and eighty, be and is hereby continued, and shall be and remain in full force, until the end of the next session of assembly.

CHAP. XIII.

Private

An ACT for the relief of John Needles of Talbot county, and Richard Clarke of Saint Mary's county, collectors of the tax.

Preamble.

WHEREAS it has been represented to this general assembly, by the petitions of John Needles of Talbot county, and Richard Clarke of Saint Mary's county, that they could not complete their collection of the public assessment for the year one thousand seven hundred and seventy-nine within the time limited by law, by reason of the shortness of the time and the difficulties they met with, whereby they have become chargeable with twenty per cent. interest: And whereas the said John Needles hath now made full payment to the treasury of the eastern shore, and the said Richard Clarke hath made full payment to the treasury of the western shore, as appears by said treasurers accounts;
