XVII. And be it enaced, That all money paid by executors, admi-Accounts of nistrators, guardians, and trustees, in consequence of this act, shall be be allowed, charged by them in their accounts, and the same in value shall be al- &c. lowed.

XVIII. And, Whereas it may happen, that one and the same person of the militia may, on account of his property in divers counties or places, be classed in several classes:

XIX. It is hereby declared and enacted, That no person shall be Persons to be draughted but subject, in any event, to the draught but in one class, and that in the in one class, county where he resides, and that the finding a recruit by any class &c. shall exempt all the persons of such class from being draughted on the default of any other class in which any of them may happen to be.

XX. And he it enacted, That if any person shall produce a recruit Persons find-to the lieutenant before the classing aforesaid, such person may apply before classing fuch recruit to discharge his own property in the same county to the may apply them to disamount of the said sixteen thousand pounds, or after classing to any charge their class he shall be in, and shall be entitled to contribution as if such re-property, &c. cruit was found after classing.

XXI. And be it enacted, That there shall be allowed to each lieute-Lieutenants nant the sum of two Spanish dollars, or the value thereof in bills of allowance, &c. credit, for every class in his county, in full for his trouble in the execution of this act, and in lieu of all his expences, except for his clerk, who shall also be allowed one dollar like money for each class.

XXII. And he it enacted, That if any lieutenant shall be absent out Field officer of his county, or shall refuse or neglect to execute this act, the oldest absence of field officer of the militia in the same county who will undertake to act lieutenant, shall have full authority to execute the powers and directions given to the lieutenant of the county by this act, and shall be entitled to the same reward as fuch lieutenant.

XXIII. and, For the discovery of deserters, and the punishment of those who entertain, harbour, or conceal them,

XXIV. Be it enacted, That if, after the first day of March next, Penalty on persons hard any free male person shall entertain, harbour, or conceal, any deserter, bouring deknowing him to be such, and shall be thereof convicted before either ferters, &c. of the judges of the general court, or any two justices of the peace, such person, so thereof convicted (unless he shall be the father of such deferter) if above fixteen and under forty-five years of age, and able bodied and fit for the service, shall, upon such conviction, be considered as an enlisted regular soldier for the term of three yeas, and may be taken as such by any officer of the Maryland line; and if any free male person, convicted as aforesaid, shall be the father of such deserter, or of or above forty-five years of age, or unfit for the fervice, he shall furnish an able bodied recruit for the war, and deliver him to the lieutenant of his county within ten days after conviction, and in case of
