LXIII. And be it enamed; That every person shall, on or before CHAP. the first day of November next, pay to the collector, or his deputy in Time for mathe diffrict where his property was valued, the refidue of the faid rate king the feimposed by this act; or he may, in discharge thereof, pay any of the cond payment, &c. specific articles aforefuld, at the prices and in the manner aforelaid, on or before the first day of November next; and if any person shall not make payment by the laid first day of November next, the respective collectors are hereby authorised and required to collect the same by distress and sale, in the manner before directed; and the collectors shall make payment by direction of the commissioners, as herein before directed, and his final account shall be settled by the commissioners on or before the fifth day of December seventeen hundred and eighty-two, and the balance thereof shall be paid by the twentieth day of the said month of December, in the same manner and under the like penalty as before directed as to the first account, and for not duly paying his first balance, the like proceedings shall be had on his bond as are before mentioned; and the faid commissioners are hereby directed to adjust and transmit the said second account, in the same manner as they are directed as to the first, on or before the first day of January seventeen hundred and eighty-three.

LXIV. And be it enafted, That the collector of each county, at the collector to time of the fettlement of his account, shall pay to every commissioner sioners, &c, twelve shillings and fix-pence for each day he shall necessarily attend; and shall also pay to the said commissioners, for the use of their clerk, twelve shillings and fix-pence per day for his service; and for the use of the faid affessors, for the full and faithful persormance of their duty under this act, any fum not under five pounds nor exceeding twenty pounds current money for each affeisor, which the said commissioners shall judge an adequate reward for his service; and the amount of all the sums so paid shall, by the said commissioners, be allowed to the faid collector, on the settlement of his account, in which account shall be expressed the name of the clerk, and the names of the assessor for each hundred, and the fum of money to them respectively allowed; and the said commissioners shall, after receipt of the said sums for the use of their clerk and of the said affessors, pay the same to them or their orders respectively on demand, under the penalty of thirty pounds current money to the party grieved.

LXV. and, Whereas it is just that persons who have no families, and pay no tax whatever in consequence of the rate imposed by this act, and who have ability, should contribute in some degree towards the expences of government and the support of the war:

LXVI. Be it enasted, That all free, able bodied, male inhabitants Single men to be allessed 150. of this state, who have no families, and are above the age of twenty- &c. one years and under fifty, and are not otherwise rated, shall be assessed the sum of fifteen shillings current money, in lieu of all other taxes, to be divided and paid in two payments as aforefaid; and the same iliall be collected by the collectors in the several counties in manner above mentioned, or by execution of the body of the perion making default; and it shall be lawful for every assessor, and he is hereby directed, on taking the name of any such free male inhabitant, to require him to give security for payment of the said fifteen shillings; and in
