

ground in Baltimore-town, distinguished on the plot of the said town by the number fifty, for which the said Nathaniel Ramsey paid the whole of the consideration money, and was put into the actual possession thereof by the said Lemuel Cravath, in consequence of the conveyance aforesaid: And whereas, at that time, no justice of the peace in the town or county of Baltimore had qualified as such, before whom the said conveyance could be acknowledged; and the duty of the said Nathaniel Ramsey, as an officer in the American army, then required him to march out of this state and join the same, whereby he was deprived of an opportunity of having the same acknowledged according to law; and the said Lemuel Cravath having since removed out of this state:

II. *Be it enacted, by the General Assembly of Maryland, That the* ^{conveyance} *said conveyance shall be, and it is hereby declared to be, as good and* ^{made valid.} *valid, to all intents and purposes, as if the same had been acknowledged according to law.*

C H A P. VII.

That another act of assembly, entitled, An act for the speedy recovery of small debts out of court, made at a session of assembly, begun and held at the city of Annapolis on Monday the sixteenth day of June, seventeen hundred and seventy-seven, be and is hereby continued, and shall be and remain in full force, for and during the term of three years, and to the end of the next session which shall happen thereafter. That another act of assembly, entitled, An act to continue an act for the regulation of officers fees, and for other purposes, made at a session of assembly, begun and held at the city of Annapolis on Tuesday the seventeenth day of October, seventeen hundred and eighty, be and is hereby continued, and shall be and remain in full force, for and during the term of one year, and to the end of the next session of assembly which shall happen thereafter. That another act of assembly, entitled, A supplement to the act for the regulation of the staple of tobacco, made at a session of assembly, begun and held at the city of Annapolis on Tuesday the seventeenth day of October, seventeen hundred and eighty, be and is hereby continued, and shall be and remain in full force, until the end of the next session of assembly.
