Comm fioners to coule land to be furveyed, &c.

II. Be it enuaed, by the General Affembly of Maryland, That the committioners of Baltimore-town atoreland, or the major part of them, be authorised and required, at any time before the first day of September next, to cause the aforesaid tracts of land and premises, or such parts thereof as they may think necessary, to be surveyed and laid out into lots, streets, lanes, and alleys, at the proper cost and expence of the proprietors thereof, in such manner as to the said commissioners, or the major part of them, shall seem convenient.

A plot to be made, &c.

III. And be it enacted, That the commissioners aforesaid, or a major part of them, shall, on or before the first day of September next, cause a correct and accurate survey and plot to be made of the said tracts and parcels of land aforesaid so laid out, and of all lots, streets, lanes, and alleys, which shall be laid out in virtue of this act; and the said plot shall be recorded amongst the records of said town, as soon as conveniently may be thereafter, there to remain as evidence of the boundaries, fituation, and location, of the said lots, and of the streets, lanes, and alleys; which said streets, lanes, and alleys, hereaster to be laid out in pursuance of this act, shall be high ways, and be so deemed and taken to all intents and purposes whatioever; and when the same shall be done, the faid tracts and parcels of land and premises, to surveyed and laid out, shall be, and is hereby declared to be, part of Baltimoretown, as fully and amply as if included originally therein, and shall have the same immunities and privileges as the said town has, or by former laws ought to have, saving to the state of Maryland, and all bodies politic and corporate, and all persons not mentioned in this act, their leveral and respective rights.

Proceedings t., he record. ed, &c.

IV. And he it enacted, That the commissioners aforesaid shall, on or before the first day of September next, cause their proceedings to be recorded amongst the records of said town, there to remain as evidence of the boundaries, fituation, and location, of faid lots, and of the streets, lanes, and alleys, atoresaid.

Proprietors to have the aptimber, &c.

V. And be it enacted, That the several proprietors aforesaid, and propriation of their heirs and affigns, shall respectively have the sole and exclusive right and authority, with the approbation and confent of the commisfioners aforefaid, or a major part of them, to appropriate, dispose of, and convert, the timber and wood growing on the earth and fand lying in such of the said streets, lanes, and alleys, as are laid out in their several and respective parts of the said tract of land.
