

RESOLUTIONS assented to,

RESOLVED, 3dly, That it is the unanimous opinion of this house, that the general assembly (the corporation and citizens of Annapolis having signified their consent) offer the said city, with its precincts, to the honourable congress, for their permanent residence; and to invest that body with such jurisdiction, authority, and power, within the same, and over the inhabitants and residents thereof, as may be required by congress, as necessary for the honour, dignity, convenience, and safety, of that body.

RESOLVED, 4thly, That it is the unanimous opinion of this house, that the general assembly present the stadt-house and public circle in the city of Annapolis (exclusive of the school-house and court-house of Anne-Arundel county, and loan-office, standing on the said circle) to the honourable congress, for their use.

RESOLVED, 5thly, That it is the unanimous opinion of this house, that the general assembly present to congress the buildings and ground in the said city, appropriated for the residence of the governor of this state, for the habitation of their president.

RESOLVED, 6thly, That it is the unanimous opinion of this house, that the general assembly offer to congress to erect, at the expence of this state, thirteen dwelling houses and other buildings, for the residence of the delegates of each of the thirteen confederated states, and that a sum not exceeding thirty thousand pounds specie be applied to that purpose.

RESOLVED, 7thly, That it is the opinion of this house, that a copy of the proceedings of the corporation of the city of Annapolis be transmitted, with the determination of the general assembly, to the honourable the congress.

RESOLVED, That the committee of claims be directed to allow on the journal of accounts, to each member of the general assembly, fourteen shillings current money per day, for his attendance during this session, and the like sum per day for itinerant charges.

RESOLVED, That the intendant of the revenue be, and he is hereby authorised and directed, out of the first monies that come into his hands from the sale of tobacco, or from any other fund not particularly appropriated to the use of the army, to lodge in the treasury a sum sufficient to defray the interest of money, according to the act of assembly for raising the supplies for the current year; and also to defray the arrearages due to the civil list.

RESOLVED, That the resolution of congress, and the letter from the superintendant of finance, respecting the quota of this state of the continental bills of credit issued by congress, be referred to the intendant of the revenue, and that he be authorised to take such measures relative thereto, as he may think best for the interest of this state, and to settle the account thereof with the superintendant of the finance.

ON the reading the petition of John Beale Howard and others, **RESOLVED**, That it is the opinion of this house, that by a provision in the late treaty between Great-Britain and the United States, John Paul, a subject of this state, who fled to the British in New-York in the year seventeen hundred and eighty-one, on suspicion of treason, may return, without any danger of prosecution for such offence.
