That another act of assembly, entitled, An act for abolishing June county courts, made at a session of assembly begun and held at the city of Annapolis the twenty-third day of March seventeen hundred and seventy-four, be and is hereby continued, and shall be and remain in full force for and during the term of seven years, and to the end of the next session of assembly which shall happen thereafter, so as not to affect the courts directed by an act passed this session to be held in June. That another act of assembly, entitled, An act for regulating the gaging of casks in Baltimore-town, made at a session of assembly begun and held at the city of Annapolis the twenty-third day of March seventeen hundred and seventy-four, be and is hereby continued, and shall be and remain in full force until the end of the next session of assembly. That another act of assembly, entitled, An act to ascertain officers fees in special courts, made at a session of assembly begun and held at the city of Annapolis the tenth day of May seventeen hundred and eighty-one, be and is hereby continued, and shall be and remain in full force for and during the term of three years, and to the end of the next session of assembly which shall happen thereafter. That another act of assembly, entitled, An act for the speedy recovery of small debts out of court, made at a session of assembly begun and held at the city of Annapolis the sixteenth day of June seventeen hundred and seventy-seven, be and is hereby continued, and shall be and remain in full force for and during the term of seven years, and to the end of the next session of assembly which shall happen thereafter. That another act of assembly, entitled, An act relating to costs in criminal cases, made at a session of assembly begun and held at the city of Annapolis the fifth day of November seventeen hundred and eighty-one, be and is hereby continued, and shall be and remain in full force for and during the term of three years, and to the end of the next session of assembly which shall happen thereafter. That another act of assembly, entitled, An act to regulate public ferries, made at a session of assembly begun and held at the city of Annapolis the fifth day of November seventeen hundred and eighty-one, be and is hereby continued, and shall be and remain in full force until the end of the next session of assembly. That another act of assembly, entitled, An act to revive and continue the act of assembly to regulate the militia, and to empower the governor to call out the militia to suppress insurrections and quiet disturbances, made at a session of assembly begun and held at the city of Annapolis the third day of November seventeen hundred and eighty-three, be and is hereby continued, and shall be and remain in full force until the end of the next session of assembly. That all those parts of an act of assembly, entitled, An act concerning estates tail and the jurisdiction of the county courts, made at a session of assembly begun and held at the city of Annapolis on the fifteenth day of June one thousand seven hundred and seventy-three, which relates to the jurisdiction of county courts, be and they are hereby continued, and shall be and remain in full force until the end of the next session of assembly. That another act of assembly, entitled, An act for the regulation of the staple of tobacco, made at a session of assembly begun and held at the city of Annapolis on the twelfth day of June seventeen hundred and eighty; and an act of assembly, entitled, A supplement to the act for the regulation of the staple of tobacco, made at a session of assembly begun and held at the city of Annapolis the seventeenth day of October seventeen hundred and eighty; and the fourth section of an act of assembly, entitled, An additional supplement to the act for the regulation of the staple of tobacco, made at a session of assembly begun and held at the city of Annapolis the tenth day of May seventeen hundred and eighty-one; be and they are hereby continued, and shall be and remain in full force until the end of the next session
