XXVIII. C H A P.

An ACT to ascertain and establish a permanent salary to Passed Mar. 6. the governor.

E it enacted, by the General Assembly of Maryland, That the gover- Governor's nor of this state for the time being, shall be entitled to receive at) the rate of one thousand pounds current money for his salary, and the same shall be paid quarterly out of the annual supplies, until the general affembly shall provide particular funds for payment.

HAP. XXIX.

An ACT for the more effectual preservation of the breed of Passed Mar. 6; wild deer.

HEREAS it appears to this general affembly, that the breed Preamble. of deer hath of late years been very much lessened, and is likely to be extinct in the several counties of this state; for the prevention whereof, it is thought proper to pals an act restraining all persons whatsoever from shooting or otherwise destroying them for a limited time:

II. Be it enacted, by the General Assembly of Maryland, That it shall Deer not to be not be lawful for any person or persons whatsoever, from and after the years, &c. end of this session of assembly during the term of fix years, to kill or otherwise destroy any deer, under the penalty of ten pounds current momey for every deer so killed or destroyed, to be recovered in the county court of the county where the said offence shall be committed, by indictment or information; one half of which said sum of ten pounds shall be applied to the use of the county, and the other half to be received by the person who shall make information thereof.

III. And be it enaded, That after the expiration of the aforefaid fix And thereafyears, no person or persons whatsoever shall shoot, kill, or otherwise destroy Nov. only, &c. any deer, except in the months of October and November yearly, under the penalty aforefaid.

IV. And be it enacted, That any person or persons whatsoever, in whose ing deers ach, hands or custody any deer's Aesh, except dried venison hams, shall be sound, considered as that shall appear to have been killed on or before the end of the said fix years, shall be deemed, taken and adjudged, the killer or destroyer of such deer, and liable to the penalty aforesaid, unless such person or persons shall make it appear who it was that really killed the same, or from whom such person thereof possessed received the same, or that the same was not killed contrary to the prohibitions of this act.

V. And be it enaked, That if any master, mistress or overseer, shall Penaltyon ferwillingly suffer any servant or servants, save or slaves, under their care or bunting deer, management, to hunt, kill or destroy, any deer, contrary to this act, the said master, mistress or overseer, so offending, shall forseit and pay the sum of ten pounds, to be recovered and applied as before directed; and if any servant or servants, slave or slaves, do or shall hunt, kill or destroy, any deer, contrary to this act, and without the privity or knowledge of their mastero milkrelo
