## XXXIX. A P. H

An ACT for confolidating the funds belonging to King Willi- Parted Man & am's school in the city of Annapolis with the funds of Saint John's college.

THEREAS the body corporate, created by the name of the Preamble. rectors, governors, trustees and visitors, of the free-schools of Maryland, but commonly known by the name of, and fince their creation called, by fundry acts of assembly, the rector, governors, trustees and visitors of King William's school, in the city of Annapolis, have represented to the general assembly, that they are desirous of appropriating the funds belonging to the said school to the benefit, support and maintenance, of Saint John's collège, in such manner as shall be consistent with and better fulfil the intentions of the founders and benefactors of the faid school, in advancing the interests of piety and learning; and have prayed that a law may pass for the said purpose;

II. Be it enafted, by the General Assembly of Maryland, That the seid Trustees, &c. rector, governors, trustees and visitors, of King William's school, shall meet at their usual place of meeting, on the twenty-second day of February, in the present year seventeen hundred and eighty-six, or on any other day thereafter, as shall be by them appointed, and appoint a committee of their own body, confishing of five persons, to meet the visitors and governors of Saint John's college, or a committee thereof, and to confer and treat with them on the terms and conditions upon which the funds and property belonging to the said school shall be conveyed to the said visitors and governors of Saint John's college; and if the said committees shall agree on the terms and conditions, the same shall be reported at a meeting of the rector, governors, trustees and visitors of King William's school, at which meeting, every member on that day in the city of Annapolis thall have notice to attend, and if the said terms and conditions shall be approved by eleven members, they, or any eleven of the faid body corporate, may, by a deed executed and acknowledged before the general court, or any judge thereof, or the county court of Anne-Arundel, or any two justices thereof, and recorded within fix months of the date among the records of the general court of the western shore, or the records of Anne-Arundel county, grant and convey unto the visitors and governors of Saint John's college, and their successors, all the lands, chattels, and choses in action, and property belonging to the faid school, upon the terms and condition to be agreed on and rarified as aforesaid, and such deed shall be sufficient to pass the faid property; and the faid visitors and governors of Saint John's college, shall thereupon have sull power to sue by the name of their own body corporate, and to recover all things to which the faid school now has a right, and which have been conveyed as aforesaid; the said visitors and governors to be named as affiguees whenever they shall profecute an adion upon a bond.

III. And be it surther enacted, That in case the terms or conditions upon Ir conditions which the property deretaid may be agreed to be transferred be broken peop to be and not complied with by the field visitors and governors of Saint John's level, &c. college, then the faid property thall revett in the rector, governors, trut-
