C H A P. XXXVII.

An ACT for valuing the lot of ground in Upper-Marlborough, cember 27. in Prince-George's county, on which the inspecting house "stands, and for paying the proprietor the value thereof."

THEREAS it is represented to the general assembly of Maryland, by Preamble. Thomas Contee, of Prince-George's county, that he is proprietor of a lot of ground in Upper-Marlborough, in the county aforefaid, on which the house for inspecting tobacco stands, and that, from the great expence of building a new warehouse thereon by the county, and the necessary annual repairs, the rent for some years past hath not been sufficient to defray the said expence; he therefore prays the same be made public property, and that he be paid the value thereof;

II. Be it enacted, by the General Assembly of Maryland, That the justices of Justices to the peace for the said county are hereby empowered and directed, at their next appoint permeeting for appointing inspectors at the several warshause in soil their next sons, &c. meeting for appointing inspectors at the several warehouses in said county, to nominate and appoint three judicious men, freeholders in said county, to value, on oath, the said lot of ground, and the old inspecting house standing thereon, exclusive of any additions and improvements that may have been made by the county; and the persons, so nominated and appointed, are hereby required to make a return to the said justices, from under their hands, of the value thereof in current money.

III. And be it enaded, That the said justices levy on the taxable property in And levy mothe said county, at their next levy court which shall be held thereafter, the full amount of such valuation, with the additional sum of six per cent. to the sheriff for collecting the same; and the said justices are hereby directed and empowered to give an order on the said sheriff to the said Thomas Contee, and on such order being given and paid as aforesaid, all the right, title and claim, which the said Thomas Contee had in and to the said lot of ground and inspecting house, shall be vested in the justices of the peace of the said county, and their successors, for ever, for the purpose of inspecting tobacco, or other public purposes.

> C H A P. XXXVIII.

An ACT to empower the justices of Queen-Anne's county to Passed December 27. levy a fum of money to complete the court-house and gaol at Centre-Ville, in faid county.

it enacted, by the General Assembly of Maryland, That it shall and may Justices to les be lawful for the justices of the peace of said county, and they are hereby &c. authorised and empowered, to assess and levy, at their next levy court, a fum of money not exceeding fix hundred pounds, with a commission of fix per, cent. for collecting the same; which said sum, to be so affested and levied, shall be collected by the sheriff of said county from the inhabitants thereof, and others having property therein, in the same manner as other public dues are collected.

II. and he it enacted, That the commissioners for erecting the court-house Commissions and gaol in the county aforefaid, or a majority of them, be and they are hereby the sheriff, authorifed, on the twentieth day of October, seventeen hundred and ninety wo, &c." to call on the sheriff of said county to pay the sum so levied, which the said commissioners, or a majority of them, are hereby authorised to receive, and to give an acquittance therefor, and apply the same, or so much thereof as may be necessary, to complete said court-house and gaol.

. III. and be it enacted, That each commissioner, for every day he shall neces. Their allowfarily attend on the duty of his appointment, shall be allowed a sum not exceeding feven shillings and fix-pence, to be ascertained and allowed by the justices aforefaid, at their levy court annually, until the faid court-house and gaol shall be completed, to be levied on the county, and collected as other public dues. and the state of the constitution of the
