XVIII. And he it enacted. That the supervisor shall and he is hereby autho-CHAP. Lil. rited and empowered to lay out the monies, or any part thereof which by this Supervilor to act he may receive from any person or persons, in the same manner he is autholay out morised to dispose of the money levied for repairing the public roads by this act. nies, &c.

And fender an account.

XIX. And be it enacted, That the supervisors of the public roads in said county be and they are hereby directed to lay before the levy court of faid county, on their annual meeting, an account on oath of the receipt and expenditure of the money received and expended by this act.

How fines are to be recovered, &c.

XX. And be it enacted, That all fines and forfeitures by this act imposed, under the sum of ten pounds current money, shall be recovered in the same manner as small debts are recoverable out of court; and every justice of the peace in the said county, before whom any of the fines by this act imposed shall be recovered, shall and he is hereby directed to lay a particular account of the same before the justices of the next succeeding levy court.

Operation: suspended.

XXI. And be it enacted, That the operation of this act in Allegany county shall be and the same is hereby suspended until the first Monday in August, in the year seventeen hundred and ninety-fix.

Commence. ment, &c.

XXII. This act to commence on the first Monday of March next, and continue in force three years, and until the end of the next session of assembly which shall happen thereafter; and from and after the first Monday of August next, the act, entitled, An act for the marking of highways, and making the heads of rivers, creeks, branches and swamps, passable, passed at September session, seventeen hundred and four, and the several supplements thereto, and also an act, entitled, An act for repairing public roads in this province, shall cease and be void, so far as they relate to the counties within this act mentioned; and the act to empower the justices of Cæcil county to streighten, and amend the public roads in said county, and to levy the expences attending the same on the assessable property of faid county, passed November session, seventeen hundred and ninety-one, except so far as relates to the roads already laid out by the commissioners of said county, shall cease to be in force, and are hereby repealed; provided always, that no new road already laid out by the justices of the levy court of Cæcil county shall be opened through any buildings, enclosed yard, garden or orchard, against the confent of the owner or owners thereof.

This act not to alter former laws, &c.

XXIII. And be it enacted, That nothing in this act contained shall extend to alter, or in any manner be construed to alter, change or repeal, an act, entitled, An act for laying out fundry turnpike roads in Baltimore county, and the supplementary acts thereto, and so much of an act, entitled, An act to streighten and amend the several public roads in several counties, as relates to Baltimore county, or any part thereof, or to destroy, divert or withdraw, the funds, or any part thereof, appropriated by law to the purposes in the said acts mentioned and expressed, or in any manner to alter the roads therein mentioned to be streightened or laid out.

XXIV. and be it enacted, That all monies arising on the assessable property monies, are to in the town of Frederick, and its additions, in Frederick county, in virtue of this act, shall be disposed of as follow: One third thereof to the public roads of the county, the other two thirds to be applied to the repairs of the streets and alleys in said town, agreeably to an act, entitled, An act to repair and amend the streets and alleys in Frederick-town, and for other purposes therein mentioned.

XXV. And be it enacted, That an act, entitled, An act to repair the public An act repealed, roads in Queen-Anne's county, passed November session, seventeen hundred and ninety-three, shall be and hereby is repealed.
