A Supplement to an act, entitled, An act for the relief of the poor of Calvert county.

Preamble.

HEREAS the provisions contained in the original act to which this is a supplement, passed at November session, seventeen hundred and ninety, have not been carried into effect;

Justices to levy money,

11. Be it enacted, by the General Assembly of Maryland, That the justices of the levy court of the said county for the time being, shall and they are hereby authorised and empowered to assess and levy, in equal proportions, on the property within the faid county liable to assessment, at the time of laying the county rate, a sum not exceeding two hundred and fifty pounds in each of the years seventeen hundred and ninety-six, seventeen hundred and ninety-seven, and seventeen hundred and ninety-eight, together with the collector's commission of fix per cent. thereon for collecting the same, which shall be collected and paid for the purposes required by the act to which this is a supplement.

Trustees appointed, &c.

III. And be it enacted, That for the time being the several persons hereaster named be and they are hereby appointed trustees of the poor within the said county; that is to fay, Messieurs Walter Smith, John Somervell, John Rawlings, Benjamin Hance, Jesse Jacob Bourne, Thomas Jenkins and Thomas H. Lyles, which persons, or the major part of them, in case of the death or absence of any of them, are hereby required, with all convenient speed, to meet at such place within their county as to them shall seem proper, to qualify themselves for the office of trustees for the poor of their county, by taking and subscribing the several oaths or affirmations required by the original law to which this is a supplement.

After 3 years justices to levy 5∫. &c.

IV. And be it enaded, That after the expiration of the said three years the justices of Calvert county levy court aforesaid for the time being, shall and they are hereby empowered to affess and levy, on the affessable property in said county, at the time of laying the county rate, a sum not exceeding five shillings on every hundred pounds of property as aforesaid in the said county, together with the collector's commission for collecting the same; which said assessment shall be made, levied, collected and paid, in the same manner as is directed by the original act.

rémain in force, &c.

Clause, &c. to V. and be it enacted, That every clause, matter and thing, which is contained in the original act, not inconsistent with or repugnant to this act, shall be and remain in as full force and effect, to all intents and purposes, as if the same had been acted under at the time required thereby.
