II. And be it enacted, That all subscriptions, and the shares obtained in consequence thereof, shall be deemed and held to be the right and property of and for the fale and exclusive use and benefit of the persons, compartnerships or bodies politic, respectively subscribing, or in whose behalf the subscriptions respectively shall be declared to be made at the time of making the farme, and all bargains, contracts, promites, agreements and engagements, in anywife contravening this provision, shall be void; and the persons, co-parenerships on bodies politic, respectively, localubications, or for whose use the subscriptions, shall bevolt clared to he made as aforefaid, fiall have, enjoy and receive, the share and flares respectively in consiquence thereof obtained, and all the interest and another interests thence arithing, any luchs bargains, contracts, promises, agreements or engagements; to the contrary, thereof iso anywife notwithstanding provided benegic LWHILL
