WHEREAS it is represented to this general assembly, that Cokesbury college, in the town of Abingdon, in Harford county, bath lately been consumed by fire, and that some malicious persons are supposed to have wickedly and wilfully set fire to the same; RESOLVED, That the governor and council be and they are hereby authorised and requested to offer such reward as they shall think proper, not exceeding two hundred dollars, payable out of the public treatury, for the discovery of the person or persons by whom the said offence may have been committed, provided that the said person or persons be brought to justice.

WHEREAS Peter Chaille, of Worcester county, did purchase of the late intendant of the revenue a tract of land in said county, by the name of Limbrick, for the sum of twenty-two shillings and six-pence current money per acre, which said tract of land was sold for one hundred acres, and by actual survey the said tract of land is sound to contain one hundred and sorty and one half acres, which surplus land the said Peter Chaille is desirous to purchase at the same price: And whereas it also appears, that since the purchase aforesaid from the said intendant, that there was a right of dower in said lands, which was not known to exist at the time, and for which the said Peter Chaille has paid the sum of twenty-two pounds ten shillings current money, which ought to be allowed; therefore, Resolved, That the state agent sell to the said Peter Chaille the said forty and one half acres of land at the price of twenty-two shillings and six-pence current money per acre, with interest from the date of the original purchase of the intendant, and that the said Peter Chaille be allowed out of the purchase money aforesaid, by the agent aforesaid, the sum of twenty-two pounds ten shillings current money as a compensation for the money by him paid for the dower aforesaid.

RESOLVED, That the treasurer of the western shore pay to Solomon Oldson, or order, one hundred and sifty-seven pounds sisteen shillings and seven-pence, with interest from the sourteenth day of January, seventeen hundred and eighty-two, in satisfaction for money paid by him to the state for thirty-eight acres and one quarter of an acre of land, deficient in his purchase of part of Queen-Ann's manor, bought of the commissioners for consistant property.

RESOLVED, That the treasurer of the western shore issue to James Hutchings a certificate for the sum of sifty pounds current money, bearing interest from the twelfth day of March, seventeen hundred and ninety-four, in lieu of one issued to him of that date and for the same sum, which is since bost, he complying with all the terms of the act, entitled, An act respecting lost certificates, passed November session, seventeen hundred and ninety-two.

RESOLVED, That Thomas Gilleland and James Boggs, of Cæcil county, be and they are hereby released from the payment of the monies to the state of Maryland arising on ordinary and retailers licences in Cæcil county for the year seventeen hundred and eighty-fix, which they might be hable to pay in consequence of their being securities for Archibald Job, sherist of said county, for the year seventeen hundred and eighty-fix, upon their paying the costs of the suits now depending against them in the eastern shore general court for the recovery of the said monies.

WHEREAS two indictments are now pending in Worcester county court against a certain Daniel Hardnett, for retailing spirituous siquors without a licence, and who was committed to close continement for the want of bail for his appearance to answer the said indictments: And whereas also the said Hardnett asterwards broke through the walls of the gaol and made his escape, and since, although diligent search and inquiry has been made, cannot be found in the county aforesaid; Resoured, That the proceedings on the said two indictments now pending against the said Daniel Hardnett for retailing spirituous siquors without a licence, shall not be prosecuted so as to charge or in any manner burthen the sheris with the payment of the said sines or penalties, in case the same cannot be recovered of the said Daniel Hardnett.
