Passed Janua- A Supplement to the act respecting certificates of surveys made on the eastern shore.

Preamble.

THEREAS it is found that the fees allowed by law to the examiner of the eastern shore are incompetent to his support, and policy and just tice require that the officers of the state should receive an adequate . compensation for the dedication of their labour and talents to the public service,

Examiner to account, &c.

II. Be it enacted, by the General Assembly of Maryland, That the examiner of the eastern shore, from and after the passage of this act, shall account every fix months, on oath, with the treasurer of the eastern shore, for all fees of his office by him received, or which may be due to him; and that the said treasurer, upon a liquidation of the said account, shall pay to the said examiner, out of any unappropriated money, such sum as, together with the said account of fees, shall make up a semi-annual salary of one hundred pounds current money.

Duration.

III. This act to continue and be in force until the twentieth day of October, one thousand eight hundred, and to the end of the next session of assembly that shall happen thereafter.

Passed Janua- A Supplement to the act, entitled, An act to erect Baltimoretown, in Baltimore county, into a city, and to incorporate the inhabitants thereof.

When elections are to be held, &c.

E it enacted, by the General Assembly of Maryland, That the next election for members of the first branch of the city council shall be held on the third Monday in January, seventeen hundred and ninety-eight, and that the election next thereafter shall be held on the first Monday of October in the same year, and that every succeeding election for members of the first branch of the city council shall be held on the first Monday in October in each and ever year for ever thereafter; that the next election for electors of the mayor, and on the members of the second branch of the city council, shall be held on the first Monday in October, in the year seventeen hundred and ninety-eight, and every succeeding election for electors of the mayor, and of the members of the secon branch of the city council, shall be held on the first Monday in October in ev second year thereafter; and that the said electors of the mayor, and of the may bers of the second branch of the city council, shall meet on the first Monda November, in the year seventeen hundred and ninety-eight, and on the Monday in November in every second year thereafter, for the purpose of eleca mayor, and members of the second branch of the city council, any thing the original act to which this is a supplement to the contrary notwithstanding.
