XXX. And be it enacted, That if the said company shall not proceed to carry on said work within two years after the passing this act, and shall not within twenty years afterwards complete the said road, according to the true intent and meaning of this act, then, in either of these cases, it shall and may be lawful for this state to reserve all and singular the rights, liberties and privileges, hereby granted to the company. Rights, &c. in certain cases, reserved.

C H A P. LXVI.

An ACT for the relief of certain foreigners therein mentioned. Passed January 20.

WHEREAS George Bower, of Washington county, William Smith, of Frederick county, Thomas White, of Baltimore county, and George Cullidon, of the city of Baltimore, have emigrated to and settled in this state, and since their emigration and settlement in this state have acquired real property therein, and their titles to such property, from their not having become naturalized before such property was acquired by them, may be called in question, to their great injury and detriment; therefore, Preamble.

II. Be it enacted, by the General Assembly of Maryland, That the title to all the real property lawfully and fairly acquired by the aforesaid George Bower, William Smith, Thomas White and George Cullidon, or either of them, whether such title be derived by grant, gift, purchase or devise, be and the same is hereby as amply and as fully vested in the aforesaid George Bower, William Smith, Thomas White and George Cullidon, to all intents and purposes, as if they had respectively been naturalized before their titles to such real property had been acquired; saving nevertheless to all persons whatsoever who may have acquired, under the present existing laws of this state, a title to any part of the real estate held by the said George Bower, William Smith, Thomas White or George Cullidon, or either of them, or any person or persons claiming under them, or either of them. Title vested, &c.

C H A P. LXVII.

An additional supplement to an act, entitled, An act to streighten and amend the several public roads in several counties, and for other purposes therein mentioned. Passed January 20.

WHEREAS by virtue of an act, entitled, A supplement to an act, entitled, An act to streighten and amend the several public roads in several counties, and for other purposes therein mentioned, passed at November session, one thousand seven hundred and ninety-one, a road has been laid out from the east end of Patrick-street, in Frederick-town, to cross Monocacy at Gomer's ferry, thence by William Hobb's to meet the Anne-Arundel road leading from the Baltimore turnpike road towards Frederick-town: And whereas part of the said road lies in Baltimore-county, and between the lines of Frederick and Anne-Arundel counties, and by the said act no power is given to the justices of Baltimore county to levy money for the purpose of keeping that part of the road in repair; Preamble.

II. Be it enacted, by the General Assembly of Maryland, That such part of the aforesaid road as lies in Baltimore county be henceforth deemed and taken as a public highway, and that the same be hereafter kept up and repaired at the county charge in the same manner as other public roads in Baltimore county are. Road deemed a highway, &c.

C H A P. LXVIII.

An ACT to authorise the laying out a public road from John Neal's lane, in Harford county, to intersect the road leading to the city of Baltimore. Passed January 20.

WHEREAS a public road leading from a place known by the name of John Neal's Lane, in Harford county, to intersect a great road leading to the city of Baltimore, will be a great public convenience, and is essentially necessary; therefore, Preamble.
