

C H A P. LXXVII.

An ACT to regulate the time of holding the orphans courts in Dorchester county, and to repeal part of the act of assembly therein mentioned.

Passed January 20.

BE it enacted, by the General Assembly of Maryland, That the orphans courts in Dorchester county shall hereafter be held on the second Tuesdays in June, August, October, December, February and April, yearly, or oftener, if need be, by adjournment.

When courts are to be held.

II. And be it enacted, That the third section of the act passed at February session, one thousand seven hundred and eighty-six, entitled, An act to revive and continue the proceedings of the orphans court of Dorchester county, be and the same is hereby repealed.

Part of an act repealed.

C H A P. LXXVIII.

An ACT to empower the vestry of Shrewsbury parish, in Kent county, to sell the glebe-land belonging to the same.

Passed January 20.

WHEREAS the vestry of Shrewsbury parish, of Kent county, have petitioned this general assembly for a law empowering them to sell the glebe-land belonging to said parish, for the purpose of purchasing other land in a more convenient and advantageous situation, and also to enable said vestry to repair the church and chapel in said parish, which are in a ruinous condition; and have represented to this general assembly, that the said vestry possess no funds to defray the expence of repairing said church and chapel; therefore,

Preamble.

BE it enacted, by the General Assembly of Maryland, That the vestry of said parish be and they are hereby empowered to sell said glebe-land, and to apply such part of the money arising from the sale thereof as they deem proper to the purchase of other land for the use of said parish, and the surplus to the reparation of said church and chapel; provided nevertheless, that the said vestry give three months previous notice, by advertisements stuck up at the court-house door for said county, and one at each door of the church and chapel respectively, of the time and place of sale.

Vestry may sell, &c.

C H A P. LXXIX.

An ACT to make a temporary allowance to the judges of the court of appeals, in addition to their permanent salaries.

Passed January 20.

BE it enacted, by the General Assembly of Maryland, That each of the judges of the court of appeals shall be entitled to receive three hundred dollars, in addition to their permanent salaries fixed by law.

Additional allowance.

II. And be it enacted, That the said sums shall be paid at the same time, and in the same manner, during the continuance of this act, as their permanent salaries are by law directed to be paid.

When to be paid.

III. This act to continue and be in force until the twentieth day of October, eighteen hundred, and until the end of the next session of assembly that shall happen thereafter.

Duration.

C H A P. LXXX.

An ACT to empower the vestry of Saint-Peter's parish, in Talbot county, to rebuild or to pull down the old church, and build a new one, and for other purposes.

Passed January 20.

WHEREAS it is represented to this general assembly, by the petition of the vestry of Saint-Peter's parish, in Talbot county, that the old church in said parish is in a ruinous situation, and have prayed that an act may pass to enable them to rebuild or to pull down the same, and build a new
