loper, always taking care to give at least twenty days public notice thereof; and and agent shall also have power to suspend the sales, from time to time, as may think most to the advantage of the state.

CHAP

XVI. And be it enacted. That the said agent shall pay into the treasury, in And pay in pecie, the amount of all specie by him received in the discharge of the duties of specie, &c. mis act.

XVII. And be it enasted, That in all cases where bonds shall be taken in Bonds to be a virtue of this act, the bonds shall be a lien on all the real property of the lien. obligors from the date thereof, or on so much of the said real property as the governor and council shall think sufficient, to be particularly mentioned in a schedule to be annexed to the said bond, in which case it shall be a lien on the property contained in such schedule, and no more, such bond and schedule to be lodged with the treasurer of the western shore.

XVIII. And be it enasted, That all bonds taken in virtue of this act shall And to exexpress the county in which the obligors respectively reside, and the treasurer of press the county, &c. the western shore shall, within one month after he receives them respectively, cause them, with the schedule annexed to them, to be recorded in the office of the clerk of the general court of the western shore, at the expence of the obligors; and a copy of the said record, certified under the hand and official seal of the aid clerk, shall be as good evidence in any court of law or equity in this state as the original bond would be if it was produced; and if any of the obligors in any such bonds reside on the eastern shore, the said treasurer shall, within six months from the time he receives the same respectively, transmit to the clerk of the general court of the eastern shore, in the same manner as papers on public service are transmitted, a copy of such bonds and schedules, certified as aforesaid by the clerk of the general court of the western shore, to be recorded in the ofhe of the clerk of the general court of the eastern shore, at the expence of the obligors, and in such case a copy of the said record, certified as aforesaid by the derk of the general court of the castern shore, shall be good evidence as aforesaid.

XIX. And be it enacted, That the said agent shall render to the treasurer of Quarterly acthe western shore distinct quarterly accounts of his receipts of all money, certifiates and bonds, in virtue of this act, and shall immediately thereupon pay and the treasurer, deliver the same to the said treasurer, who shall, in his annual report to the ge- &c. neral assembly, state fully and particularly the money, certificates and bonds, by him received from the said agent, and the times when the same were received and accounted for.

XX. And be it enacted. That the said agent shall render a fair and full ac- Afair account count of his several proceedings under the authority of this act to the general assembly at their next sections and anishing the country of this act to the general assembly, &c. assembly at their next session, and within the first ten days after its commenceient, in which account shall be specified, under distinct heads, his own receipts, and those of the treasurer, and of all transfers of stock upon which he may be ntitled to commission, and in which shall also be contained a particular estimate of his commissions, shewing how and upon what the same arose due.

XXI. And be it enacted, That the said agent shall be allowed for his services Commission following commissions, to wit: For all payments actually made to either of allowed. treasurers in virtue of this act, three per cent. and for all bonds with security en by the said agent in virtue of this act, three per cent. provided that the nole amount of his commission shall not exceed five hundred pounds current oney, and he shall lay an account of the same, on oath, before the next session affembly.

XII. And be it enaded, That hereafter it shall be the duty of the agent and The fifteen treasurers of the western and eastern shores respectively to receive, as well the per cent. to be received, &c. on per cents interest, if any shall have accrued, as all other the arrearages dare now or may hereafter become due from fines, forfeitures and amercia-
