An ACT to enable the corporation of the city of Annapolis to lay a tax on property within the said city, and the precincts thereof.

Preamble.

THEREAS it is represented to this general assembly, that the annual ordinary expences of the corporation of the city of Annapolis, for the support of the mayor's court and its proper officers, and the new cessary charge of repairing the streets, require considerable sums of money, and the funds belonging to the said city are very trivial, and greatly inadequate to the . annual expences thereof;

Corporation to lay a tax, Жc.

II. Be it enacted, by the General Affembly of Maryland, That the corporation of the faid city of Annapolis, and their successors, be and they are hereby authorifed to lay a tax, not exceeding two shillings and fix-pence in any one year for every hundred pounds of property within the faid city, and the precincts thereof, as the said corporation may think proper.

Duration.

III. This act to continue and be in force till the first day of November, in the year eighteen hundred, and till the end of the next session of assembly that shall happen thereafter.

Preamble.

THEREAS the sheriff for the time being, on the releasement of any insolvent debtor under the provisions of the act to which this is a supplement, is made the trustee for the benefit of the creditors of fuch infolyent debtor, and all the real and personal property, and all causes of action, of such debtor, at the time of his or her releasement, are vested by the faid act in such sheriff, and no provision is made for the completion of the trust in case it shall not have been fully executed by such sheriff during his continuance in office,
