C H A P. VIII.

ACT to authorize and empower the justices of the levy court for Saint-Mary's county to assess and levy annually a sum of money for the purpose therein mentioned.

Passed Jan. 13.

WHEREAS it is represented to this general assembly, by the petition of Sarah Thompson, of Saint-Mary's county, that she is a poor woman, the mother of a dumb child about six years of age, and entirely deprived of the use of its limbs, and praying that a law may pass, authorizing the justices of the levy court for Saint-Mary's county to levy a sum of money for the support of her said child; and the prayer of the petitioner appearing reasonable, therefore,

Preamble.

II. BE IT ENACTED, by the General Assembly of Maryland, That the justices of the levy court for Saint-Mary's county be and they are hereby authorized and empowered to assess and levy annually on said county the sum of thirty dollars, for the support and maintenance of the child aforesaid, which shall be collected and paid by the collector or collectors of the county aforesaid to the said Sarah Thompson, or to any other person appointed guardian or trustee to the said child, agreeably to the order of the levy court aforesaid.

C H A P. IX.

ACT to authorize and empower the levy court of Saint-Mary's county to assess and levy annually a sum of money for the purpose therein mentioned.

Passed Jan. 13.

WHEREAS it is represented to this general assembly, by the petition of Joseph Flower, that he is extremely poor, and is so unfortunate as to have a son seven years of age, dumb, and entirely deprived of his intellects, and praying that a law may pass for the support and maintenance of his said son out of the poor-house; and the prayer of the said petitioner appearing reasonable, therefore,

Preamble.

II. BE IT ENACTED, by the General Assembly of Maryland, That the justices of the levy court for Saint-Mary's county be and they are hereby authorized and empowered to assess and levy annually on said county the sum of thirty dollars, for the support and maintenance of James Flower, and to appoint Joseph Flower, or any other person, guardian or trustee to the said James Flower, to collect and receive the same agreeably to the order of the levy court aforesaid.

C H A P. X.

ACT, entitled, An act to revive and continue the several acts of assembly therein mentioned to the end of this present session of assembly, and to establish and confirm all acts done in pursuance of said laws.

Passed Jan. 13.

WHEREAS several important laws have expired since the last session of assembly, and various acts have been done in pursuance of them as if in full force, and it is highly necessary and important that all such acts should be legalized and confirmed,

Preamble.

II. BE IT ENACTED, by the General Assembly of Maryland, That all and every act of the general assembly of this state, which has ceased and expired since the end of the last session of assembly, be and they and each of them are hereby revived and continued until the end of the present session of assembly, and are hereby declared to be in full force, and to have effect and operation from the periods when they respectively expired, subject nevertheless to the operation of all laws repealing, altering or changing, any part of them.

Acts revived.

III. AND BE IT ENACTED, That all acts done in pursuance of any of said laws, as if in force, since they respectively expired, shall have the same effect, operation and validity, as if the said several laws had not expired.

C H A P. XI.

ACT to empower the levy court of Harford county to assess and levy a sum of money for the purpose therein mentioned.

Passed Jan. 13.

WHEREAS William Bankhead, of Harford county, by his petition to this general assembly hath set forth, that he hath a brother, who has for a considerable time been afflicted with a lameness: And whereas James Green, by his petition hath set forth, that he is blind, and has a family which he is unable to support, and severally praying that a law may pass to provide their support out of the poor-house; and the prayer of the said petitioners appearing reasonable, therefore,

Preamble.

BE IT ENACTED, by the General Assembly of Maryland, That the justices of Harford county be and they are hereby directed and empowered, at their levy courts annually, as long as they shall in their discretion may think proper, to assess and levy on said county two several sums of money, not exceeding in either case forty dollars, for the support and maintenance respectively of the said James Green, and of the said brother of the said William Bankhead, and that the respective sums be collected and paid annually to the aforesaid William Bankhead, and the said James Green, by the collector or collectors of Harford county, for the purpose aforesaid, agreeable to the orders of the levy court of said county.
