Passed Jan. 18. An ACT to release the right of this state in a lot in the city of Baltimore to Charles Jessop, and others.

Right released, PE IT ENACTED, by the General Assembly of Maryland, That the right of this state in and to a D lot of ground in the city of Baltimore, diltinguished by the number thirty, shall be and is hereby released to Charles Jessop, George Lightnar, Patrick Mullan, Jonathan Askew, Jonathan Rutter, Henry Worthington, Jacob Miller and John Honeycomb, and their heirs, in feveralty, and in fuch parts, portions or shares thereof, as they now respectively claim, possess, hold and enjoy the fame; faving and referving nevertheless to all persons whatsoever their several and refpeclive rights, heretofore acquired in and to the faid lot of ground number thirty.

> C H A P. XCI.

Passed Jan. 18. A Supplement to an act, entitled, An act to authorise the building a market. house on the county wharf in Chester-town, in Kent county, and for the

regulation of the faid market. Preamble.

HEREAS by the act to which this is a supplement, passed at this present session of assembly, it is enacted, that the days for holding the markets shall be on Tuesdays and Fridays, and it is represented to this general assembly that the market-days will interfere with the present market, as established; therefore,

Market-days changed.

II. BE IT ENACTED, by the General Assembly of Maryland, That the market-days for the faid market to be built and established by virtue of the act to which this is a supplement, shall be Mondays and Fridays in every week instead of Tuesdays and Fridays, any thing in the said to the contrary notwithstanding.

Passed Jan. 18. A Further supplement to an act, entitled, An act to unite the freeschools of Saint-Mary's, Charles and Prince-George's counties.

Preamble.

THEREAS it appears right and reasonable that Calvert county should be associated with the counties of Saint-Mary's, Charles and Prince-George's, in the management of Charlotte-Hall school,

Truftees appointed for Calvert county.

II. BE IT ENACTED, by the General Affembly of Maryland, That Calvert county be henceforth entitled to have seven trustees for the management of Charlotte-Hall school, who shall have and possess all the powers and authorities that the trustees of any of the said counties now have by law, and that colonel Benjamin Mackall, Thomas Bourne, John Chesley, junior, Michael Taney, Joseph Wilkinson, Richard Grahame and Thomas Parran, be and are hereby declared trustees on the part of Calvert county for the faid school, in addition to the trustees appointed for the counties aforesaid.

And BE IT ENACTED, That whenever a vacancy shall happen from any cause in the trusare to be filled tees appointed for Calvert county, it shall and may be lawful for the president and trustees of Charlotte-Hall school, at all times, to supply such vacancy, in the manner directed by the act w which this is a further supplement.

THEREAS it is represented to this general assembly, that Wilhem and Jan Willink, merchants in Amsterdam, are desirous of purchasing real property in the town of Havrede Grace, in Harford county, provided they shall be empowered by the laws of this state to hold the same: And whereas the enabling the aforesaid persons to hold real property in the town of Havre-de-Grace as aforesaid might, by introducing large sums of money into this state, be productive of great advantage, not only to the town of Havre-de-Grace, but to the state at large therefore,

II.
