meetings of the board of examiners, the modes and times of electing officers, filling up vacancies in the medical board, and to do and perform fuch other things as may be requifite for carrying this act into execution, and which may not be repugnant to the constitution and laws of this state, on the United States.

C H A P.

An ACT respecting write of babeas corpus.

Passed Jan. 20.

BE IT ENACTED, by the General Assembly of Maryland, That the several county courts in this Courts, &c. state, during their respective littings, and at all other times the chief justice of the several may issue writs, districts respectively, be and they are hereby authorised and empowered, upon application, to issue their writ of babeas corpus, and cause to be brought before them, any person or persons who are or shall be in confinement within their respective jurisdictions, and to inquire into the cause of fuch confinement, and either discharge, admit to bail, or commit such person or persons, as the case may require, in the same manner as is now practised by the judges of the general court.

C H A P. CVII.

An ACT for the promotion of literature in this state.

Passed Jan. 20

HEREAS the establishment and promotion of literary institutions for the liberal education Preamble. of youth, under proper regulations, in different parts of this state, would have beneficial effects in training up and continuing a fuccession of able and virtuous characters for discharging the various offices and duties of public and private life;

H. BE IT ENACTED, by the General Affembly of Maryland, That the fum of five hundred pounds, Sum discentipart of the sum heretofore appropriated to Washington college, shall be and the same is hereby nued. discontinued, after the first day of May next.

III. AND BE IT ENACTED, That the treasurer of the western shore shall be for ever hereaster Treasurer to buthorised and required to pay annually, on or before the first day of June, to the several semi- pay, &c. naries of learning herein after enumerated, in the following proportions, to wit: To the vifitors and trustees of Washington academy, in Somerset county, or to their order, the sum of eight hundred dollars; to John Edmondson, Nicholas Hammond, Samuel Chamberlaine, Thomas J. Bullett, William Hayward, Ennolls Martin and Stephen Theodore Johnson, and their successors, as trustees for the use of an academy to be established in Talbot county, eight hundred dollars; to the president and trustees of Charlotte-Hall school, or to their order, eight hundred dollars; to the visitors and trustees of the Frederick county school, or to their order, eight hundred dollars.

IV. And BE IT ENACTED, That Charles Ridgely, of Hampton, Harry Dorfey Gough, Thomas Trustees ap-Cockey, of Thomas, John Tolly Worthington, Patrick Allifon. doctor John Carroll, doctor John Pointed, &c. Archer, Jesse Jarrett, Nicholas Day M'Comas, James Bond, doctor Jacob Hall and doctor Thomas H. Berckhead, be and hereby are appointed trustees for an academy to be erected in Baltimore or Harford county, and that the faid trustees shall locate, erect and superintend, the faid academy, in the same manner that other trustees are authorised to do under the provisions of this Act; and the faid trustees are hereby authorised to receive from the treasurer of the western shore the sum of eight hundred dollars annually, at the several times on which the trustees for other academies instituted under this act are entitled to receive the same, and the said monies, when received, to apply, in their discretion, towards the purchase of grounds for the site of said academy, building the same, or payment of tutors therein employed; and the said trustees are also authorised to receive, by donation, any lands or tenements for the use and benefit of said school, provided the same are not in extent more than fifty acres, or personal property in amount not more than two thousand pounds.

V. AND BE IT ENACTED, That the visitors and directors of each of the schools aforesaid shall visitors to reannually, on or before the twenty-fifth day of November in each year, return to the general turn an account affembly an account of all fums by them received in virtue of this act, the names of the persons to whom paid, for what use, as also a state of their respective schools, the name of the teacher or teachers engaged, and the number and names of the scholars actually at faid schools, under the penalty of a forfeiture of their donations respectively upon a failure of making/the return as aforefaid.

CYIII. Α

An ACT declaring what shall be evidence in certain cases therein mentioned. THEREAS copies of the proceedings of the governor and council, or of the treasury, or Preamble. of the office of the auditor, are not receivable as evidence: And whereas it is inexpedient that civil officers of government should be frequently obliged to leave their offices and attend to give evidence of matters relating to their offices;

II. BE IT ENACTED, by the General Assembly of Maryland, That a copy of any of the books, Copies attested papers, entries or proceedings, of the governor and council, attefted by the clerk of the council, and also a copy of any of the books, papers, entries and proceedings, of the treasury, attested by the treasurer, and also a copy of any of the books, papers, entries and proceedings, of the office of the auditor of the state, attested by the auditor, and also a copy of any of the books, papers, entries and proceedings, in pollettion of the register of the land-office, not being matter of record, and by him attested, shall be received in evidence in any court of law or equity, or before any judge, justice, or other tribunal in this state, in the same manner, and to have the same effect, as if the original books, papers, entries or proceedings, were themselves produced; provided the faid copies, so attested, are sworn to be true copies by the persons respectively attelling them.
