government-house, a particular account of the expenditure of which he is hereby requested to lay before this house at their next session.

**RESOLVED,** That John Shaw be and he is hereby appointed and authorized to sell and dispose of, for ready money, all old and useless articles of furniture in the government-house belonging to the state, and account with the treasurer of the western shore, after deducting ten per centum for his trouble arising from the sale of said property.

**RESOLVED,** That the governor and council be authorized and empowered to procure, by importation or otherwise, nineteen copies of Richardson's treatise upon last wills and testaments, and that one copy thereof be transmitted to each of the orphans courts in this state, for the use of each court.

**RESOLVED,** That the treasurer of the western shore be and he is hereby authorized and required to pay to the adjutant-general of this state for the time being the sum of six hundred dollars, and no more, in quarterly payments, as his salary for the year one thousand seven hundred and ninety-nine, provided the said adjutant-general reside or keep an office at the seat of government.

**RESOLVED,** That the treasurer of the western shore be authorized and he is hereby directed to pay annually to each brigade inspector of this state the sum of one hundred dollars, as a compensation for his services in the discharge of his duties.

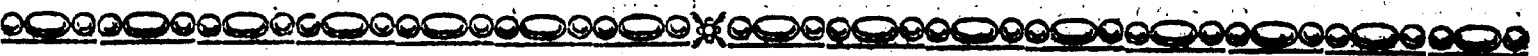
**RESOLVED,** That the governor and council be authorized and empowered to provide carriages for the six pieces of ordnance now lying dismounted in the city of Annapolis, and cause the same to be mounted, and rendered in all respects fit for service, and the same, when completed, to apply to the use of the fort building in the city of Annapolis, subject to the future disposition of the general assembly.

Whereas in the year seventeen hundred and ninety-six it was resolved by the general assembly of Maryland, that the treasurer of the western shore should advance, on loan, to Jesse Hollingworth, Philip Rogers and Emanuel Kent, the sum of eight thousand dollars, to be applied to rebuilding and completing the academy in Baltimore-town which had been previous to that time consumed by fire: And whereas there is good reason to believe that the said sum of money will never be demanded; wherefore **RESOLVED,** That the said resolution be and is hereby rescinded.

**RESOLVED,** That the treasurer of the western shore pay the sum of three thousand dollars to the mayor of the city of Baltimore, to be by him applied to the completing and furnishing the hospital in Baltimore county for the relief of indigent sick persons, and the reception and care of lunatics; provided that the said mayor shall first give bond, with security, for the due and faithful application of the said sum of money to the purpose aforesaid, and provided also, that the said treasurer shall first be assured and satisfied, that the inhabitants of Baltimore county have also contributed and secured to be paid to the mayor aforesaid an equal sum of money towards the completing and finishing the said hospital.

**RESOLVED,** That the agent to the state of Maryland do immediately proceed to sell the property taken under fieri facias issued on a judgment, the state of Maryland against William Allein, rendered at October term, seventeen hundred and ninety-two, and that the amount of the proceeds thereof be paid by the agent to Daniel Kent, for the use of Sarah Weems Allein, wife of William Allein.

**RESOLVED,** That the resolution passed at November session, one thousand seven hundred and ninety-seven, so far as relates to the money deposited in the treasury for the use of British creditors, which obliges persons applying to produce a voucher that the claims are paid, or secured to be paid, be rescinded.
